We are SO excited to be preparing for another fun-filled summer here at Coastal Day School!! We are open seven (7) weeks, offering a fun outing each day for our campers! Our camp is for rising kindergarteners through eighth grade. Our doors open at 7:30 each morning and we close at 6pm. Campers must arrive by 9am each morning for our outing. Our return time will be noted on our calendar, but is usually around 1pm, except Wednesdays when we arrive back around 5pm. Campers need a lunch, snack, and multiple water bottles each day. Please apply sunscreen each morning before drop-off. We will reapply midmorning. We will gladly accept spray sunscreen donations throughout the summer...we go through a LOT! Campers and staff will not be required to wear a face mask, but anyone that wishes to wear one will be welcome to.

To register your child for our summer camp program, we will need completed paperwork, along with the non-refundable, non-transferable registration fee of \$10 per week your child is enrolling for. For example, if you register one child for three weeks of camp, you would be required to pay a \$30 registration fee at the time of enrollment. If you decide to add additional weeks at any point during the summer (pending availability), you will then be required to pay the additional \$10 per week, per child. Spaces are first come, first serve.

Tuition is based on what you enroll for, not what days your child actually attends. Once paperwork is submitted, we cannot change or take away any weeks registered for, and you will be required to pay for them in full. We do not make any exceptions to this policy. We provide a quality program with low student/teacher ratios, along with fun outings and activities daily. It is important that we receive payment for every space reserved to continue providing the fun program our campers have come to love! We feel badly when plans change and parents are still expected to pay, but please understand that this is required to keep our camp open and functioning. If multiple parents were to ask each week to make changes, it would severely affect our ability to continue to operate, as it is difficult to fill spaces last minute when parents have already made other arrangements for their children once our program is full. Again, we will not make any exceptions to this rule for any reason.

Tuition for our summer camp program is \$85 for 2-days (Tuesday/Thursday), \$125 for 3-days (Monday/Wednesday/Friday), or a discounted rate of \$180.00 for five consecutive days. **You are responsible for payment for each week you register for regardless of attendance. Tuition will not be refunded, prorated, or forgiven, and cannot be transferred to another child or week. You are paying for the days you reserve, not the days your child attends. There will be no exceptions made.** There is a \$10 per child, per week registration fee. This is also non-refundable and non-transferable. All field trips and activities are included in the weekly tuition.

***Initial next to each week you would like to register your child for and circle how many days you want each week. Once this form has been turned in, you are responsible for payment for every week you initial regardless of attendance and you will not be able to cancel or switch weeks.**

Illness/COVID-19 Policy

In order to provide a safe and clean environment for all children at CDS parents MUST NOT bring their child if they are exhibiting any symptoms listed below:

- A temperature of 100 degrees or higher
- Red, watery eyes (pink eye)
- Undiagnosed rash
- Excessive runny nose/ sneezing
- Excessive cough
- Sore Throat
- Nausea/ Vomiting
- Diarrhea
- Covid-19 or Flu Symptoms

Every child will have their temperature taken as they walk in the front door. Any child with a fever (100 degrees or higher) will not be permitted to stay or attend for the following 24 hours. Children will immediately wash their hands prior to going into their classroom. Parents are not permitted in classrooms. Drop off will need to happen at the front desk. Classroom materials, furniture, and toys will be sanitized daily, along with frequent handwashing. We will follow recommendations by the CDC, as they are made.

If any child or staff member tests positive for the coronavirus during the summer, we will notify everyone via our remind app. We will need to follow any recommendations by health officials, so we are not sure what this will entail, but will communicate the details at that time. It could possibly mean being closed or a classroom

quarantining. If a member of your household tests positive at any point, your child will not be permitted to return to CDS until they are released by the health department to do so. If a household member is awaiting test results, the child cannot attend. If your child has been exposed, your child will not be permitted to return until they are released by the health department.

As you are probably aware, closures during this pandemic have caused serious financial stress to our business, like many other businesses and families. If a member of your household tests positive at any point, a member of your household is awaiting test results, or your child is quarantining from exposure or a positive test result, you will be required to pay tuition for the dates your child is registered. **Please note this policy prior to registering as it will be enforced, and no exceptions will be made.**

By signing below, I am confirming that I have been provided with a copy of Coastal Day School's Coronavirus Policy for the 2022 summer camp program and understand the policy in its entirety. I understand that sending my child to summer camp at CDS does come with the risk of exposure and possible infection of the coronavirus. I understand I will be responsible for paying tuition regardless of absences if my child is quarantining due to testing positive or exposure.
