With DRE, your customers will receive:

- Access to over 100 HD channels
- HD Interactive Programming Guide
- HD receivers
- Unmanaged system capabilities
- Hospitality RC70H anti-microbial remotes

DRE property requirements:

- DRE is designed for and can only be sold in budget/economy hotels and in healthcare properties
- DRE cannot be sold in mid-price/upscale/luxury hotels or in the Strategic Hospitality Accounts (Hilton, Hyatt, Starwood, Kimpton, Marriott)

DRE technical requirements:

- H25 HD receivers with DRE system design
- Receiver staging by distributor required
- Hospitality RC70H anti-microbial remotes
- D2 Advantage SWiM[™] based system
- Management Control Server (MCS) and associated networking equipment are not required

Because there is no MCS in DRE systems, the following features are not available:

- No DVRs
- No Local Content Insertion (LCI)
- No MCS features
- No Guest Message Display
- No Channel favorites list
- No Co-branded interactive programming guide
- No Remote Default Reset
- No Property Management System (PMS) integration
- No Centralized Parental Control:
 - Per room, Parental Control may be enabled by the property management staff if a guest requests it
 - Refer to DRE Parental Control Feature Installation for instructions
 - The following Parental Control language must be included in all contracts to customers:

Property Owner understands that a parental control feature will not be auto enabled in the receivers throughout the property. If requested by a guest or you otherwise want to enable this feature, you must turn it on and off manually. Enabling and disabling instructions should be provided by your Dealer. If not, please contact your Dealer. Property management may program an individual receiver with the parental control feature after reviewing the instructions provided by the Dealer. The enabling and disabling of the parental control feature on the individual receiver is the sole responsibility of the property management.

L-Band System Discontinued

Sometime in 2013, DRE systems will be the only approved in-room receiver solution for hotels or healthcare properties. Once this goes into effect, L-Band systems will no longer be approved for installation on those types of properties. Stay tuned for an official announcement.

DRE Plus has the benefits of DRE with the added features of an MCS. DRE Plus can be tailored for each property to match the expectations of each L&I customer.

DRE Plus technical requirements:

- H25 or HR24 receivers with DRE system design
- Receiver staging by distributor required
- Hospitality RC70H anti-microbial remotes
- D2 Advantage SWiM[™] based system
- MCS
- MDF and IDF network switches
- DECAs
- Diplexers

DRE certification is required!

- DRE certification training is available on the SBCA website

Dealers who are already DRE certified may sell both solutions with no further training.
