#### AUDIT SCOPE:

Review of a conventional Cooling/Cold Storage operation. The facility is approximately 27,000 square feet including the refrigerated loading dock and cooler rooms totaling approximately 17,000 square feet and operates twelve months. Cooling units have regular fans. There are no blast coolers. A couple of commodities are topped with ice from the ice machine which is emptied, cleaned and sanitized weekly with a solution of 200 ppm available chlorine. All of the products this facility handles are received and shipped in the same crates or cartons as received, that is, box-in, box-out. This company does some cross-docking. Upon receipt, pallets are immediately placed in the cooler for temporary storage. Product is separated and counted per customer order, kept on pallets which are labeled with a unique tracking number and placed in the staging area of the loading dock or loaded onto pre-cooled refrigerated trucks. The only allergens present, seafood, eggs, dairy, nuts and peanuts were properly labeled and isolated. Four male workers were present during the audit.
