**TREASURER'S REPORT:**

Stover reported that most of the people being assessed for the work on Spring Grove Road have paid their assessments. Those not paid will be added to the winter tax roll.

There is a balance of \$40,008.19 in the checking account.

**CLERK'S REPORT:**

Wills presented a list of the check disbursements to be approved. Total expenses were \$17,050.53

A motion was made by Stover and, seconded by Leyrer to accept the report and approve payment of the expenses. Motion carried.

**PLANNING COMMISSION:**

Next meeting is December 4, 2019 at 7:00 p.m. The Commission will be reviewing the contract bid forms.

**COMMISSIONER'S REPORT:**

Commissioner Petersen gave an update on county business. Millage requests were approved for the March election for the Sheriff Department and the Library. The Prosecutor will be hiring a part-time employee. Petersen was asked if the township could opt out of the contract for a deputy that we now have if the millage passes. He replied that it was possible.

**ZONING REPORT:**

Dale updated the board on the status of the zoning complaints. Several letters still need to be sent out, one site was ticketed, and other sites are showing progress.

**OLD BUSINESS:**Sewer Update

Peterman talked to the drain commissioner; she has promised that the turnover will be completed before she retires. The board is considering scheduling a meeting with all parties involved to discuss the agreement.

Fire Truck

The fire truck was finally ready and was at the meeting for viewing. Repairs are complete and everything seems to be working good. Township residents may be able to get lower fire insurance rates because of the new tanker.

**NEW BUSINESS:**Snow Plow Bids

Bids for plowing were received from Hopkins Lawn Care & Snow Removal, LLC; Morris Lawn Care & Snow Removal, LLC and Mark Walters. The Board reviewed all the bids.

A motion was made by Stover and seconded by Welder to accept the bid from Hopkins Lawn Care & Snow Removal, LLC. Motion carried.
