Board of Equalization

No minutes for Board of Equalization.

The following 2020 monthly reports were received, reviewed and placed on file: October- I Cardenas, Co Sheriff, J Schildt, Clk of Dist Ct, K Brandt, Co Clk and L McCoy, Co Treas.

The October minutes of the Morrill/Scotts Bluff County Extension meeting were received, reviewed and placed on file.

Robin Stuart, Hospital Administrator, and Frank Lussetto, Chairman of Hospital Board, were present. Stuart presented the October Financials. She reported that 520 people were tested for Covid in October. She said the machine is 98% accurate. She said they will have a full time Orthopedist after the first of the year. Stuart & Lussetto discussed the age of the ambulances that they purchased back when the hospital took over the transporting of patients. Stuart said there are funds available from the COVID Funds for ambulances and that they are looking to purchase two. Robin said their auditors said this should be covered. They discussed the purchasing of two with 4-Wheel drive because of the places where they sometime have to pick people up and also because of the snow. Metz said he suggested that the county take money out of the Inheritance Fund for the purchase and if the hospital receives the COVID Funds, it will be put back into the Inheritance Fund or the hospital will reimburse if COVID funds are not available. Motion was made by Sterkel, seconded by Batterman, to provide the money in the amount of \$244,000 from the Inheritance Fund for the purchase of ambulances and to reimburse the Fund when COVID funds are obtained or hospital repays. Yeas: Sterkel, Batterman and Metz. Nays: None. Motion carried.

Susanna Batterman, Commissioner, addressed the letter that Robin had written regarding the staff at the hospital being impacted by the COVID, either because of more patients or being exposed themselves and quarantined. Batterman said she had Panhandle Health was encouraging counties to support the guidelines out there. Metz said counties cannot mandate masks, that cities can and the Governor can, but it is not the county's responsibility. Stuart said they are not asking

for mask mandates, they just want the public to be aware and to respect the health care workers and that each individual is responsible for their own well-being. She and Lussetto both commented on how taxing this has been on the health care workers across the nation. The Board agreed that they respect and commend the health care workers and appreciate what they are doing.

Loretta McCoy, County Treasurer, presented the Distress Warrants that were issued November 2, 2020. There were 111 issued, but two paid before the Sheriff had to contact them, so 109 for a total of \$53,788.52. Motion was made by Batterman, seconded by Sterkel, to approve and sign the Distress Warrant report. Yeas: Batterman, Sterkel and Metz. Nays: None. Motion carried.

Kathy Brandt, County Clerk, presented the Resolution and Certification from the Nebraska Department of Transportation, certifying that Hoerler was appointed and continues to serve for the year 2020 as Highway Superintendent. Brandt says this guarantees that the county will receive their Incentive Payment in February. Motion was made by Sterkel, seconded by Batterman, to approve the Chairman to sign the certification and to adopt the following resolution:

RESOLUTION #2020-50 SIGNING OF THE YEAR-END CERTIFICATION OF COUNTY HIGHWAY SUPERINTENDENT 2020

Whereas: State of Nebraska Statutes, sections 39-2302 and 39-2501 through 39-2505 details the requirements that must be met in order for a county to qualify for an annual Incentive Payment; and

Whereas: The State of Nebraska Department of Transportation (NDOT) requires each county must annually certify (by December 31st of each year) the appointment of the County Highway Superintendent to the NDOT using the Year-End Certification of County Highway Superintendent; and

Whereas: The NDOT requires that such certification shall also include a copy of the meeting minutes showing the appointment of the County Highway Superintendent by their name as it appears on their License (if applicable), their License Number and Class of License (if applicable), the type of appointment, i.e., employed or under contract (consultant, or interlocal agreement with another county and/or incorporated municipality), and the beginning date of the appointment; and

Whereas: The NDOT also requires that such Year-End Certification of County Highway Superintendent form shall be signed by the County Board Chairperson and shall include a copy of a resolution of the County Board authorizing the signing of the Year-End Certification of County Highway Superintendent form by the County Board Chairperson.

Be it resolved that the County Board Chairperson of MORRILL County is hereby authorized to sign the attached Year-End Certification of County Highway Superintendent form.
