## Picture Day -Saturday, April 7 and 8, 2018

In March, picture day schedules and order forms for individual and group pictures were passed out at dance. Additional individual order forms are also available for those who are interested in getting their dancers pictures taken in different costumes. Please read the times carefully and know what all you need to bring so pictures run smoothly. **Pictures will be taken at Sines Studio by the post office in Meyersdale, not at the dance studio.** I have attached the picture day packet for you to have.

## Finale Practice Schedule

Designated classes performing are listed below. The finale is the dance that closes the recital. A ten year slideshow and dance by the company dancers and teachers will open the show. The majority of the choreography will be taught in class. These two practices will be utilized to set up spacing. This is why it is so important for all dancers to be present for both practices.

Costume- Show shirts and black leggings/shorts/capris with designated shoes (black bottoms need purchased on your own)

***It makes it hard trying to keep spacing for individuals who are missing.***

## Backstage Help

I am looking for anyone interested in helping backstage for our recital. I would greatly appreciate any helping hands with the dancers as the backstage helpers are truly the heart of the show. There is a sign-up sheet in the front lobby by the payment box if you would kindly sign it for me. Please sign as soon as possible so I know how much help I can anticipate having on recital day. Even if you do not plan on helping backstage, I do ask that anyone with younger dancers come backstage to assist their child with their costume changes as the backstage moms can't dress every dancer. There is no personal videotaping permitted during the show out of respect for the videographer. These DVDs are high-quality and professionally shot.
