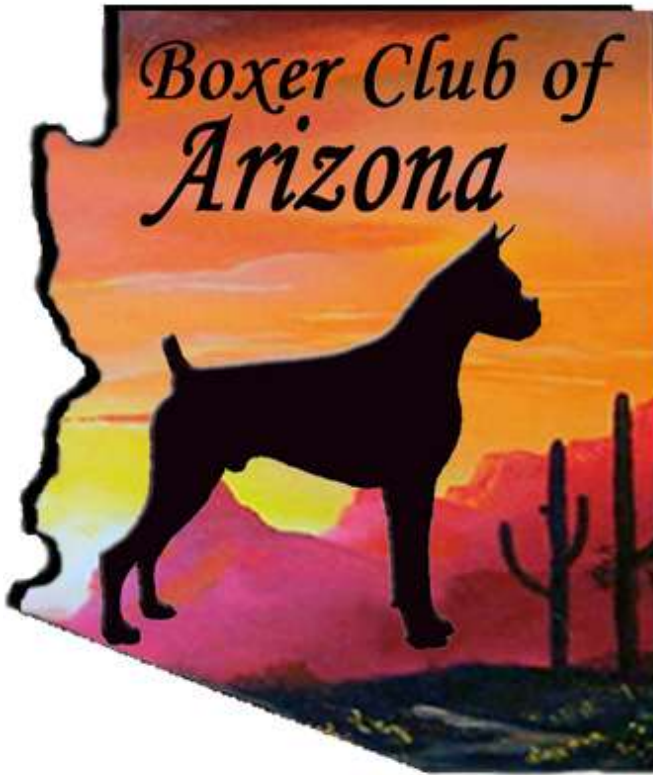

## ***Sweepstakes Judge Heather Thorne***

I first got involved in the breed over 10 years ago by purchasing two pets from a mid-west breeder, Hanna and Kash. Much was to learn about the breed over the next few years. After finding that Hanna had severe food allergies I found Jessica Koziel (Lemko Boxers) via the Internet and started to educate myself on food allergies and raw feeding. From this a friendship developed which I found myself attending shows, helping out, and learning more with Jessica as a mentor. Two years later after waiting for the perfect show pup, I was introduced to Jane Guy of Salgray Boxers and along came Jezra. Jezra (Ch. Salgray's Star Duster) not only would become my first champion but the foundation of Bay Cliff Boxers. Jezra taught me so much, inside and outside the ring, and while I lost her this past January, I am very lucky to see her live through her offspring. I have finished four Boxers; have had four class winners at the National and very close to having the first American Bred Champion with an IPO1 title. From my first litter, I bred BISS GCH. Bay Cliff N Salgray's Star Factor "Daughty" who can be seen in the specials ring and made an impressive final cut of males at the 2017 National with Brooke Moyer. Along with Daughtry, I have three young females from my last litter that are currently in pursuit of their Championships. I have been the President of the Rhode Island Boxer Club for the past 4 years and active supporter of all Boxers Clubs and Boxer Rescue. I have had the privileged over the past year to judge the sweepstakes for Boxer Club of Western New York and the Potomac Boxer Club. I have also seen my grand sweeps winner from one of my assignment take winners' dog at this year's National. I am thankful and honored to judge the sweepstakes for the Boxer Club of AZ sweeps this year as well as to all those who have entered under me. My sincere thanks!



## ***Judge Sioux Forsyth-Green***

**Sioux was born in Southbury, Connecticut, and currently resides in Pinehurst, North Carolina. She is the only child of the late great Bob and Jane Forsyth who were world renowned all-Breed handlers, and later international, all-breed judges. Sioux was born the morning after her mother went Best In Show at the prestigious Westchester Kennel Club. She was destined to be a dog person.**

**Sioux grew up helping her parents show boxers from a very early age. "Boxer time" was always busy at the Blue Bird since it carried most of the entry to the shows in the Northeast during the '60's, '70's and early '80's.**

**Sioux finished her first champion at the tender age of three, a Japanese Chin. She has shown many boxers to their championship, as well as group and Best In Show winners. For over 40 years, Ms. Forsyth-Green has established herself in the dog world. She learned the business not only from her parents, but also from many well-known and respected handlers such as Mark Threlfall, Bonnie Threlfall, Richard Bauer, Paul Edwards and Peter Green.**

**Sioux Forsyth-Green has juggled life as a professional handler, single mother, and wife and business owner. She is currently working as one of the new up and coming well respected AKC Judges. She loves what she is doing!**



**JUDGE MR. JOHN P. WADE**

**John Wade became active in purebred dogs in 1959 when he purchased a Dachshund for his mother on Mother's day and has stayed continuously involved since. Early on, he worked for an AKC Licensed All Breed Handler and two terrier breeding kennels, eventually becoming a handler. He also enjoyed success as a breeder and exhibitor of Dachshunds with numerous top winning Smooth Dachshunds either owned or bred by the Wade Family. Wade further pursued his interest and became a multiple-group judge. Employed on two occasions by the American Kennel Club as a member of their Executive Field Staff and Director of Judging Operations he has deep knowledge of the inner workings of the sport. He currently is licensed to judge the Hound, Working, Herding, Terrier, Toy, Non-Sporting group, Miscellaneous breeds, and Jr Showmanship along with Best In Show.**
