Secretary's report: was read. Motion to accept as read Phil Barker, 2nd Normand Robert Passed

Treasurers Report: Brett gave the financial report from the last months income and expenses. Motion to accept Vivian Clark, 2nd Larry Gaskell Passed

Trail Administrators Report: John was unable to attend so Don Revane gave the trail updates. Winter Grant-in-Aid is all set. Brett gave John Thompson the slips to finish up the grant funding on trail repairs. A fee increase was mention for grooming and registrations to which a lengthy discussion ensued over fee increases and its potential impact on memberships, the purchase of grooming equipment in the future and how it will impact the non-profit status of all the clubs.

Twin bridge trail is done. Thanks to everyone that came out to help. The Brighton's bridge has been delayed due to the inclement weather conditions that are too wet to get the equipment out there. We do not want to negatively impact the landowner's property, so this will be a rescheduled work party when it dries up.

Old Business: In the last newsletter we spoke about the re-route by Eccard Farm & Dube's. Penny reached out to Fish & Game, LT. David Walsh expressing our concerns and sent him our information to see if <u>He</u> would be willing to advise us of our next steps, to help with the reroute. He contacted Wendy at Society for the Protection of NH Forest. He also sent a letter of recommendation with accolades for the club and their commitment to be good stewards of the land. That he only had positive reviews of our area and the clubs hard work at maintaining what we already have. Within hours we had a response. Don Revane then submitted a complete package of GPS coordinates, detailed maps of the area in question and all previous correspondence back to Wendy for review and are awaiting her comments, suggestions, or approvals.

The gates were delivered to the landowner for safety and security of the trail as mentioned at the last meeting.

Unfortunately, the Trunk or Treat on October 27th was cancelled due to the poor weather, but we are looking forward to trying it again next year.

New Business: Half Moon Pond bridge needs to be checked to see if the bridge is still secure after the heavy rainfall we have been getting. Dennis Harrington is trying to contact the

McGuerty's for landowner permission which will enhance the trail off Half Moon Pond Rd. after several attempts by mail and calls we have been unable to reach them for access. So that trail work is on hold still.

Christmas Social will be hosted again by Jim & Gwen Gaskell on December 1st at their home which is always a great time. BYOB and bring an Hors d'oeuvre of your choice to share! It's a great time! Social will begin after a brief meeting!
