The independent, volunteer board of Shoreview residents and friends selects grant recipients based on established criteria and is responsible for leadership and fundraising. The endowment funds of the Shoreview Community Foundation are invested with and managed by the Saint Paul & Minnesota Foundation in a balanced fund. There is a small operating fund. Besides investment through the Saint Paul & Minnesota Foundation, we receive management support and advice from their experienced staff.

Thanks to generous support from donors like you, we provided grants to seven community projects that benefit Shoreview, while continuing to raise money to increase our endowment for future projects.
