

Angels Baby Sanctuary Travel Competition **Terms and Conditions**

1 Competition:

This Competition is promoted by Angels Baby Sanctuary, Registration Number: **NPO 121-449** (“the “Promoter”). In these Terms and Conditions, we refer to Angels Baby Sanctuary as “the Promoter” and we refer to participants and winners as “you”.

2 Competition Period:

The Competition commences at, 01h00 on **18 July 2019** and ends at 23h00 on 19 November 2020 (the “Competition Period”).

3 Who May Enter?

3.1 To be eligible to enter, the entrant must:

- 3.1.1 be a natural person;
- 3.1.2 be a South African citizen or a permanent South African resident holding a valid passport; or if the entrant is a Foreign National, must hold a valid passport with the relevant South African visa;
- 3.1.3 be eligible for a visa to travel to Bali; and
- 3.1.4 be 18 (eighteen) years or older.

3.2 Clauses 3.1.2, 3.1.3, 3.1.4 also apply to the winner’s travel partner. Should the winner elect a minor as a travel partner, then the necessary legislated required documentation for minors to travel outside of South Africa is required.

3.3 Participation in this Competition excludes employees, directors, members, partners of, or any other person who, directly or indirectly controls or is controlled by the Promoter and Sponsors and the spouses, life partners, immediate family members of the Promoter and Sponsors.

3.4 The person that the winner elects to use the second ticket (“Partner”) must also fulfil all eligibility criteria and accept and adhere to these Terms and Conditions.

4 How to Enter:

4.1 During the Competition Period, the entrants that meet all of the criteria referred to in clause 3 above must do the following in order to stand a chance to win:

4.1.1 Participate in the Angels Baby Sanctuary Travel Competition by purchasing a Raffle Ticket to the value of R25.00.

4.1.2 Complete a Competition entry form;

Once the entrant has fulfilled the requirements above, he or she will be automatically entered into the lucky draw.

5 The Draw:

5.1 The lucky draw shall take place on 20 November 2019

5.2 The winner will be notified telephonically by the Promoter as soon as possible after the draw.

5.3 The winner will be selected randomly.

6 The Prize:

- 6.1 The winner shall win 2(two) economy class return flight tickets from O.R Tambo International Airport to **Bali**
- 6.2 The Prize excludes:
 - 6.2.1 Accommodation;
 - 6.2.2 Transfers;
 - 6.2.3 All Meals or entertainment expenses;
 - 6.2.4 Travel and medical insurance;
 - 6.2.5 A daily allowance for sundries;
 - 6.2.6 Visa and/or associated costs;
 - 6.2.6 Any vaccinations required;
 - 6.2.7 Spending money;
 - 6.2.8 medical expenses; and/or
 - 6.2.8 Any other expense whatsoever.

7 General:

- 7.1 The Prize must be redeemed before 20 April 2020 In the event that the winner does not redeem the Prize by 20 April 2020, the Prize will expire and may not be used.
- 7.2 The 2(two) tickets making up the Prize, must have the same outbound and inbound flights on the same date and time. In other words, both return tickets must be booked from O. R Tambo International Airport to Bali
- 7.3 The Prize may not be amended, transferred, cancelled, sold or exchanged for another prize or for cash.
- 7.4 The draw results to determine the winner is final and no correspondence will be entered into.
- 7.5 The Promoter, its respective directors, affiliates, members, partners, employees, agents, consultants, suppliers, contractors, subsidiaries and sponsors assume no liability whatsoever for any direct or indirect loss or damage, including but not limited to physical harm or death, howsoever arising from or as a result of an entrant's participation in the Competition or the entrant and it's partner's redemption of any Prize in terms of this Competition, or from any amendments to Prize details and/or the terms and conditions of this Competition. All entrants (including the winner) hereby expressly indemnify the Promoters in this regard and shall hold it harmless from all and any claims arising from or as a result of the above reasons.
- 7.6 In the event that the winner is unable to redeem the Prize for any reason or is disqualified for any reason the winner will forfeit the Prize and the second name will be drawn as the winner.
- 7.7 In so far as it is necessary, required by law or required by Promoter, the Promoter reserves the right to vary the nature of the Competition, the Prize, or these terms and conditions, or withdraw the Prize or the Competition upon notice in this regard being published on its website www.angelsbaby.org or in another appropriate medium.
- 7.8 The Promoters shall attempt to contact the winner for a period of 1 (one) week after his or her name is drawn as a winner. In the event that the winner is either uncontactable or in the event that the winner rejects, or declines acceptance of the Prize, the winner shall forfeit the Prize and the Prize shall be subject to a new draw.
- 7.9 The Promoter reserves the right to withhold the Prize until it is entirely satisfied that the claimant of the Prize is the bona fide winner and reserves the right to call for such proof as it may deem necessary.

- 7.10 The Promoter shall request that the winner consents to their name, image and likeness being used and published by the Promoter in connection with this Competition for a period of 12 (twelve) months after they are announced as winner. The winner may decline the use of their name, likeness and image by the Promoter.
- 7.11 By entering this Competition entrants signify their consent to be bound by the terms and conditions contained herein
- 7.12 By entering the Competition all entrants give their consent to receive various marketing and promotional material from the Promoter.
- 7.13 The winner agrees that it is an express condition of the Competition that in order to be eligible to redeem the Prize, the winner shall be required to sign the appropriate acknowledgement of receipt of the prize, as well as an indemnity and/or waiver of liability as reflected in these terms.
- 7.15 The winner acknowledges and accepts that the Promoter may utilize a third party (the Promoters' authorized agent/s) to contact the winner to arrange for all matters related to the Prize and the Promoter shall provide the winners information to such third party.
- 7.16 The winner acknowledges that if they miss any of the arranged flights, the costs of alternative flights and any other costs shall be for the winner's account and indemnifies the Promoter as such.
- 7.17 The winner acknowledges that any costs associated with luggage, loss, damage or any related costs to luggage shall be for the winner's account and indemnifies the Promoter as such.
