SUMMARY:

January 2019-Current:

- SFY20 Homelessness Funding RFP:
 - Required general and project specific measurable goals. Individual program targets will be used in funded contracts to inform SFY20 statewide benchmarks
 - Required annual data quality monitoring and validation for all awardees
 - Required annual UHMIS end-user recertification training
 - Identified which organizations need help with generating HUD required federal reports
 - Determined training needs
- Plan on collaborating with the University of Utah on a strategic plan focused on data quality and performance measures
- Administered a survey for End-Users to identify what training they need for HMIS.
 - We have determined that 54% of respondents want data quality focused training
 - 72% of End-Users requested in-person training, but 75% also indicated that they would be comfortable with digital training (37% for a YouTube format video and 38% for web conferencing)
- Completed a data specific training focused on high quality data entry for '100 More Housed' goal that was determined by the Resource Center Transition Steering Team
- Corrected workflow for the Department of Workforce Services employees entering into HMIS for CSA cards that created many clients with missing Universal Data Elements
- Updated New End-User and Operation Rio Grande training

May 1 – June 30, 2019:

- UHMIS staff will provide additional training opportunities for End-Users across the State monthly
 - On May 15, HMIS will be traveling to Carbon/Emery LHCC to give several trainings in person. All other LHCCs will have similar meetings offered over the next year
 - The training day will include four 15 minute sessions for one-on-one HMIS troubleshooting and in-person data correction
 - The training will be recorded for digital consumption for all LHCCs before May 30
- A YouTube playlist on DWS account will be created to make training more accessible and more focused
 - On May 1st, the first data quality training videos will be recorded for YouTube
 - Videos will be created starting with the specific data points for the '100 More Housed' goal
 - Additional recordings will be made as necessary and updated as data standards change
 - UHMIS End-Users will be able to complete required training using a combination of videos and tests provided by the HMIS team
- System Performance Measures (SPM) are due to HUD by the end of May
 - SPMs will be used to identify organizations that need individualized training, these organizations will get first visit priority for in person training

Data Validation and Contract Monitoring (ongoing):

- Establish Data Quality Monitoring and Validation Plans
 - Use HUDs HMIS Data Quality Monitoring Toolkit, System Performance Measure Standards, and Data Quality report to establish a measurable method to monitor and improve data quality
- Establish Data Quality Improvement Plans for UHMIS
 - Contract funded entities
 - All UHMIS entities (regardless of funding)
- Establish a ranking system for State funded programs to both motivate poor performing organizations and reward better performing organizations
- Create an annual training for all HMIS end-users
 - SFY20 RFP requires annual training (re-certification) for all HMIS End-Users - Training must be provided by a HCD UHMIS staff member
 - Dates training will be required to be approved by HMIS steering committee

2. **SFY20 Homelessness Funding RFP Summary**

FUNDING PRIORITIES

Funding priority is placed on moving people experiencing homelessness from shelters and off the streets into decent, safe, and affordable housing or providing supportive services to promote housing retention and improve or maintain quality of life. Additionally, the State Homeless Coordinating Committee is committed to prioritizing projects that address goals, best practices and mandates aligned with:

- [*Home, Together*](#), the Federal Strategic Plan to Prevent and End Homelessness.
- The Homeless Emergency Assistance and Rapid Transition to Housing (HEARTH) Act of 2009 and the Emergency Solutions Grant (ESG), which together focus on a community-wide commitment to ending homelessness.

HOMELESSNESS FUNDING GRANT SOURCES

- Federal Emergency Solutions Grant (CFDA# 14.231)
- Federal Temporary Assistance for Needy Families (CFDA# 93.558)
- Homeless to Housing (Utah Code 35A-8-505, 604, and 605)
- Pamela Atkinson Homeless Trust (Utah Code 35A-8-602 and 603)

FUNDING PURPOSES

Homelessness Funding will emphasize diversion, emergency housing and shelter, distinct housing needs and client self-sufficiency, including placement in meaningful employment, occupational training activities, and/or special services to meet the unique needs of the homeless including:

- Families with children

- Transitional-aged youth
- Single men or single women
- Veterans
- Victims of domestic violence
- Individuals with a disability, behavioral health disorders, including mental health or substance use disorders
- Individuals who are medically frail or terminally ill
- Individuals exiting prison or jail, or
- Individuals who suffer from other serious challenges to employment and self-sufficiency

PROJECT TYPES

- Diversion
- Emergency Shelter
- HMIS Comparable Database
- Homelessness Prevention
- Permanent Supportive Housing
- Rapid Re-Housing
- Single Room Occupancy
- Street Outreach
- Transitional Housing
- Other – Projects that absolutely do not fall under any other category

PERFORMANCE MEASURES

Contract performance measures were developed by DWS HCD. These measures were reviewed and approved by the State Homeless Coordinating Committee. Performance measures are largely influenced by the HUD System Performance Measures. Funded projects must set individualized targets based on project specifics. Measures are reported quarterly throughout the contract year, and in a final annual report.

- Number of project leavers
- Average length of stay in project
- Number of exits into a permanent destination

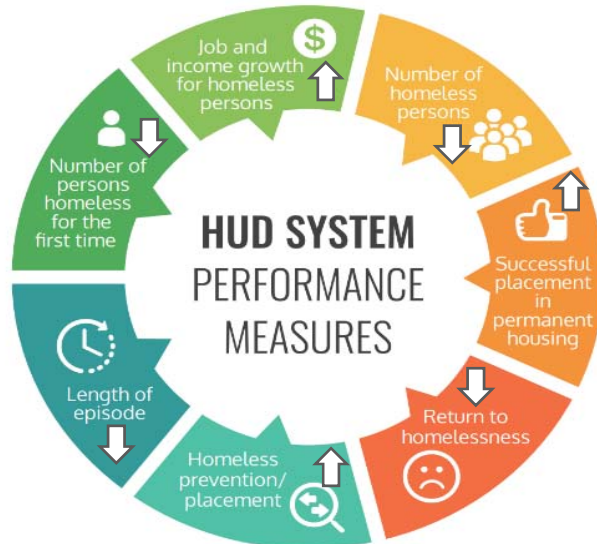

SYSTEM PERFORMANCE MEASURES

To improve system performance for people experiencing homelessness, HUD has developed several system-level performance measures to be reported on by homeless systems nationwide. These measures help communities more accurately measure their impacts, successes, and challenges in order to inform strategic decisions in the development of local homeless systems. DWS, HCD Homelessness Funding aligns contract measures with the HUD System Performance Measures.



3. Allocation Committee Homelessness Funding Summary REQUEST FOR PROPOSAL (RFP) TIMELINE

- July 1, 2019 – June 30, 2020 - Contract period for funding
- March 14 or 15, 2019 - The RFP required applicants to attend a pre-proposal training in order to submit an application
- Monday, March 25, 2019 - Part 1 of the application was due
- Tuesday, April 9, 2019 - Part 2 (final application) was due
- Sunday, April 14, 2019 - Extended due date for final applications

ALLOCATION COMMITTEE PROCESS

- Friday, April 12 - All day proposal review training held
- Monday, April 15 - Applications available for review via Webgrants
- Thursday, April 25 - First all day review of proposal recommendations held
- Tuesday, April 30 - Second all day review of proposal recommendations held
- April 30 – May 2 – Final reviews by staff and Allocation Committee
- Friday, May 3 - Final electronic recommendations provided to Allocation Committee
- Friday, May 3 - Final recommendations approved by the Allocation Committee

APPLICATIONS SUMMARY

- 52 agencies submitted applications – 49 agencies recommended for funding
- 149 project applications – 102 projects recommended for funding
- \$40,696,576 total funding requests
- \$17,391,238 total funding available
- \$23,305,338 project requests not funded

REVIEW PROCESS AND RATIONALE FOR RECOMMENDATIONS

- Allocation Committee members were assigned to groups based on area of expertise, local community involvement, and past experience with Homelessness Funding review
- Proposals were grouped by geographic location (Local Homeless Coordinating Committee-LHCC)
- Each Allocation Committee group designated an HCD staff lead to facilitate priority discussions, review scoring, and record notes
- Proposals reviewed by Allocation Committee members were scored based on:
 1. Agency overview
 2. 'Housing First' best practices
 3. Homeless or formerly homeless individual engagement
 4. Project performance
 5. SHCC purposes and alignment
 6. Project goals
 7. LHCC involvement
 8. Timeframe for implementation
 9. Contingency plan
 10. Sustaining services
 11. Prioritizing Services
 12. Case management certification plan
 13. Project budget
 14. Funding gap analysis
- HCD and ASD staff reviewed every project proposal and scored based on:
 1. HMIS project measures and outcomes
 - Comparison of FY18 and FY19 target data for existing project contracts
 - FY19 target data used for new project analysis
 2. Data completeness and timeliness
 3. Funding alignment and support
 4. Budget and fiscal risk
 5. Monitoring and technical assistance responsiveness
 6. Housing first
- HCD and ASD staff conducted follow-up conversations to review budget or program concerns with organizations recommended by the Allocation Committee
- Consideration was taken for first year of the new homeless resource center service system
- Allocation Committee considered community priorities in each LHCC during prioritization of project types, including and not limited to:
 1. Salt Lake LHCC
 - The need for continuing basic services that support housing projects,
 - Projects that have a significant impact on the new service system,
 - Case management for existing PSH housing vouchers,
 - Essential and ancillary services such as: Landlord mediation, mobile medical clinic, day center services,
 - New prevention projects were not considered
 - All new projects were critically reviewed for appropriate costs and realistic performance expectations

- 2. Balance of State and Mountainland
 - Priority given to emergency shelter, diversion and housing projects
 - All new projects were critically reviewed for appropriate costs and realistic performance expectations
- Combination of need in the community, scoring and performance were all considered in recommendations for funding
- Capital projects were not considered
- Equipment and furniture in budget proposals were critically examined
- “Other” projects recommended for funding include The INN Between, VOA CWC, Mobile Clinic
- Transitional Housing projects recommended are for specific needs and subpopulations including DV, Youth and Rural
- Admin costs were removed from project consideration, however, in HCD negotiation of final budgets for contract, admin costs will be allowable

4. RFP Award Conditions

- Award letters will be provided to organizations contingent upon SHCC approval
- Contracts are contingent upon the organization completing a DWS risk assessment and negotiation of final budgets and scope of work performance outcomes
- Funding is contingent upon HCD receiving official federal funding award letters
 - If the ESG or TANF award is less than anticipated, HCD seeking approval to cut a percentage from each award to make up the deficiency, and
 - If the ESG or TANF award is more than anticipated, HCD is seeking approval to utilize funding for eligible projects if reviewed and approved by the HCD
- SFY19 close-out will not be complete until August 2019 at which time HCD will know if there is additional roll-over funding available. If additional roll-over funding is available, and dependent on the funding source available, the Allocation Committee is seeking approval to allow HCD to fund:
 - Housing Connect (formerly Housing Authority of the County of Salt Lake) rapid rehousing projects
 - First Step House housing projects
 - Shelter the Homeless diversion projects
 - Volunteers of America Center for Women and Children and diversion projects
 - Midvale Family Shelter
 - YWCA housing project

SUBMITTED BY: Housing and Community Development Staff

SUMMARY:

1. During the 2019 Legislative session two agencies were identified for one-time funding to be allocated by SHCC for specific purposes proposed to the legislature. One agency receives ongoing funding from the 2018 session. These agencies were outlined for State Homeless Funds for FY20 in the following amounts:

- \$100,000 – Friends of Switchpoint (one time)
- \$100,000 – St. Anne’s Center, Lantern House (one time)
- \$100,000 – The INN Between (on-going)

Each entity has submitted a budget to Housing and Community Development for the use of these funds. These funds require State Homeless Coordinating Committee approval.

Budget Summaries:

1. Friends of Switchpoint - page 21

- Switchpoint proposes utilizing funds for 1 FTE licensed clinical social worker to provide support to clients, support of clients with employment and quality of life services, and supports for the shelter. An itemized budget is included in this proposal.

2. St. Anne’s Center, Lantern House - page 23

- St. Anne’s proposes utilizing funds for 1 FTE Community Case Manager and 2.25 FTE Shelter and Security Staff to support clients at Lantern House Shelter. An Itemized budget is included in this proposal

3. The INN Between - page 24

- These funds are part of an on-going appropriation to support clients of the INN between medical respite facilities. Funds are proposed to be used to for Certified Nursing Assistant’s salaries and benefits. An itemized budget is included in this proposal.

SUMMARY:

In December 2018 a Performance Audit of Utah's Homeless Services was presented by the Office of the Legislative Auditor General. House Bill 342 "Homeless Provider Oversight Amendments" requires the SHCC to prepare and implement a statewide strategy for minimizing homelessness in the State that achieves the following objectives:

1. Outlines specific goals and measurable benchmarks for progress,
2. Identifies gaps in service delivery to the variety of homeless populations,
3. Provides recommendations to the government and the Legislature on strategies, policies, and procedures, and programs to address the needs of the homeless populations in the state, and
4. Identifies best practices and recommends improvements in coordinating service delivery to the variety of homeless populations through the use of electronic databases and through data sharing among service providers.

[Utah Code, Title 35A, Chapter 8, Part 6, Section 602 (1)]

Housing and Community Development has requested The University of Utah, Public Affairs Programs to submit a proposal for the development of a statewide strategic plan to minimize homelessness. Approval to move forward with this planning effort will enable SHCC to take steps to create a more results-oriented system for serving the homeless. Additionally, an updated strategic plan will enable providers, business and funders to be guided by a common strategy to reduce homelessness.

FY19 funding for this project is part of the FY19 approved set-aside, page 26.

FY20 funding for this project is included as part of the FY20 proposed set-aside, page 27

RECOMMENDATIONS:
