- I understand and agree to defend, indemnify and hold harmless, Tip Top Riding Club, arena owners, and District 6 of the NARC&SP members and officers, from and against any liability for any injury or loss while on the premises and from and against any and all claims, losses, liabilities, attorney's fees, medical fees, cost and expenditures incurred for any injury or loss suffered, whether or not such injury or loss resulted directly or indirectly, from any reason including, but not limited to, the negligent or grossly negligent acts or omissions of the Tip Top Riding Club and District 6 of the NARC&SP members and officers.

- Furthermore, the undersigned agrees that Tip Top Riding Club, arena owners, and District 6 of the NARC&SP members and officers, shall not be liable or responsible for, and shall be indemnified and held harmless by the undersigned from and against any and all suits, action, losses, damages, claims or liability of any character, type or description, including all expenses of litigation, court costs and attorney's fees, for injury or death to any person or persons, or animal or property arising out of, or occasioned by, directly or indirectly, the use of the premises and entry into the equine events hosted on this day.

3) The undersigned agrees to be fully responsible for keeping the trash in their parking area and all other areas clean and disposed of in trash bags or trash cans, located on the premise.

4) The undersigned agrees to be solely liable for the costs of repair or replacement of any of the arena equipment or property that is damaged by the negligence of the undersigned or his/her family/guest
