MA (A & B Licenses), ME, NH & VT

The Code Update Program at Mammoth Fire Alarms, Inc. will satisfy the continuing education requirements for license renewal for the States of Massachusetts, Maine, New Hampshire and Vermont. Electricians holding Massachusetts Licenses can meet the 21 hour requirement for license renewal by attending our two-day 15-hour NEC update class and our one-day 6-hour professional development classes. All Massachusetts licenses expired on July 31, 2019 and the 21 clock hours of continuing education must be completed by the renewal deadline. All 15-hour continuing education must be completed for New Hampshire Licensees by December 31, 2017 and by your next renewal for Maine and Vermont. Our 15-hour National Electrical Code (NEC) class features the IAEI Analysis of Changes enhanced by our instructor's own material including the Massachusetts Electrical Code amendments. This cycle we will be offering electrical as well as fire alarm 6-hour professional development classes.

Our Electrical Code Instructor/MA Provider for this Code cycle is Mark Hilbert. Mark has been in the electrical industry for over 30 years and is a licensed master electrician in MA, NH and Maine. Mark is the current chair of CMP 2 representing the International Association of Electrical Inspectors. He is a NEC consultant and seminar instructor for the National Fire Protection Association and the International Association of Electrical Inspectors.
