Because of this, the HOA board is considering canceling the event. It has been a very popular event in past years, but misuse that creates a safety hazard for our residents cannot be tolerated. VOLUNTEERS NEEDED

We are all blessed to live in a small community where most residents take pride in the upkeep of their property. Our streets and park are clear of trash and litter. We have a community picnic in the summer and holiday party in the winter. Dumpsters are provided twice a year for residents, document shredding and electronic recycling one a year. Covenants are enforced to insure the integrity of the neighborhood and increase the values of our properties. Much of this is due to the small group of volunteers in the neighborhood. Volunteers serve on the HOA board of directors, pick up trash in the park and along Parker Rd, supervise the landscaping and irrigation, clean and repair the tennis courts, spread mulch in the common areas to reduce water consumption, and plan the social events. Without volunteers, we would all be paying a professional HOA management company to provide these services. The cost of these services would more than double our annual HOA dues. Currently we have nine volunteers that serve on the HOA Board of Directors. One has served 4 3-year terms, two have served 3 3-year terms, four have served 2 3-three year terms, and one is in their first three-year term. In addition, we have two non-board members that supervise the landscaping and irrigation companies that maintain our common areas. Several board members have decided that they will not serve another term. If we are unable to seat a Board of Directors, we will be required by state law to engage a professional management company to oversee the HOA. Do you want to pay \$1,000/year dues? Think about giving a few hours to your community.
