# STRATTON SCHOOL BOARD TOWN OF STRATTON VT MAY 5, 2016



The Stratton School Board held its monthly meeting on May 5, 2016 at the Stratton Town Office. The meeting was called to order at 7:05 P.M.

**ATTENDING:** Siobhan Eddy Young, Director, Lorraine M. Weeks-Newell, Secretary, Alyson Marcucci, Stratton Town Treasurer, WCSU Superintendent, Steven John, WCSU Financial Officer, Bud DeBonis, and Heather Bennett.

#### **BUSINESS:**

Ms. Bennett attended the meeting to request resident information for enrolling her children in the 2016/2017 school year. She will know in August whether or not her children, grades 7 & 11 will be attending school. The Board has requested that she provide her marriage certificate as part of her proof of residency.

In December 2015, Ms. Julianna Moore applied for residency in order to receive tuition assistance for her son. She submitted her information. The Board asked that she provide a copy of her drivers license as soon as it was available. She assured the Board that she would. In February, the school board contacted Ms. Julianna Moore reminding her of its request. To this date, she has not provided her license. A registered letter will be sent to her address on file regarding this issue.

Bud DeBonis, Chief Financial Officer for the WCSU, met with the Board to correct an error that was made in his calculations for the 2016/2017 school budget. The error, in the amount of \$45,600, was not carried through in the final calculations. The shortage was noted by Treasurer Marcucci. The underspending of tuition should compensate for the error and the tax rate will not be affected.
