ORDINANCE NO. 93 - 1
AN ORDINANCE FOR THE TEMPORARY USE
OF REPLACEMENT COST IN LIEU OF
MARKET VALUE FOR CALCULATING
SUBSTANTIAL DAMAGE

WHEREAS, THE VILLAGE OF HAMBURG, CALHOUN COUNTY, ILLINOIS has experienced major flooding of a catastrophic nature and subsequent loss of property and is covered under the Presidential Disaster Declaration (DR 997).

WHEREAS, THE VILLAGE OF HAMBURG, CALHOUN COUNTY, ILLINOIS, has adopted floodplain management regulations to reduce future flood losses pursuant to the Illinois Municipal Code (65 IL Compiled Statues 5/1-2-1, 5/11-30-8 and 5/11-31-2), and is a participating community in the National Flood Insurance Program (NFIP) and must maintain in force those regulations as a condition of continuted NFIP participation.

WHEREAS, current National Flood Insurance Program (NFIP) Standards required the Village of HAMBURG, Calhoun County, Illinois to use 50% of a building's market value before the damage as the threshold for applying local floodplain management requirements for any building that is substantially damaged in Special Flood Hazard Areas.

WHEREAS, the Federal Insurance Administration, has interpreted the National Flood Insurance Program requirements to allow the use of replacement cost in lieu of market value in this particular post-catastrophic disaster setting in the market.

WHEREAS, the use of replacement cost, which is the cost of replacing a structure of like kind using pre-flood costs for labor and materials, can be readily determined and is an effective means for identyfing substantially damaged buildings.

WHEREAS, due to the catastrophic nature of the flood disaster, the use of replacement cost may be in the best interest of the VILLAGE OF HAMBURG, CALHOUN COUNTY, ILLINOIS, for the protection of the public health, safety, and general welfare.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE
OF HAMBURG, CALHOUN COUNTY, ILLINOIS, THAT SECTION 7 AN ORDINANCE REGULATING
DEVELOPMENT IN FLOODPLAIN AREAS WITHIN THE VILLAGE OF
Passed and approved by the Board of Trustees 1984
be amended to add the following:

## SECTION I -- PROVISION TO BE ADDED

Replacement cost in lieu of market value shall be used only for determing substantial damage of those buildings in Special Flood Hazard Areas that were damaged directly as a result of the flood event which occurred between April 13, 1993 and September 7, 1993. The use of replacement cost cannot be used for determining whether or not a building is being substantially improved by reasons other than substantial damages which occurred as a result of this flood event.

- Replacement cost in lieu of market value shall be used only for determining substantial damage of those buildings in Special Flood Hazard Areas that were damaged directly as a result of the flood event which occurred between April 13, 1993 and September 7, 1993. The use of replacement cost cannot be used for determining whether or not a building is being substantially improved by reasons other than substantial damages which occurred as a result of this flood event.
- iii (b) If the work described in any floodplain development permit shall not have been begun within one hundred eighty (180) days from the date of issuance thereof in accordance with this ordinance said permit shall expire and be cancelled by the Building Inspector who shall give written notice of such cancellation to the applicant for such permit.
- iii (c) The provision of this Ordinance allowing the temporary use of replacement cost in lieu of market value shall expire on December 31, 1993.
- SECTION II THAT this ordinance shall be in full force and effect from and after its passage, approval, and publication.
- THAT the Village Clerk shall forward a duly certified copy of this Ordinance to (1) David Schein, Federal Emergency Management Agency, Region V -- 4th Floor, 175 W. Jackson Blvd., Chicago, IL 60604, (2) Paul Osman, 3215 Executive Park Drive, Springfield, IL 62794, Illinois Department of Transportation, Division of Water Resources, and (3) Calhoun County Building Inspector.
