All stakes, single course without a bird field. Quail or Chukar will be released for all stakes except Puppy stakes. A blank cartridge will not be fired in Puppy stakes. Horseback handling permitted in all stakes except those noted as **walking**. AKC tracking collars permitted to be used in accordance with AKC Rules and regulations. Bitches in season may run at stakes end except in the Open All Age & Open Puppy. **NO roading** dogs behind the gallery in any stake.

Standard AKC rosettes to all placed dogs. Prizes to all 1st placed dogs except OLGD. OLGD purse; 40% of entry distributed as; 1-40, 2-30, 3-20, and 4- 10 % .

Early reservations suggested due to the Holidays.

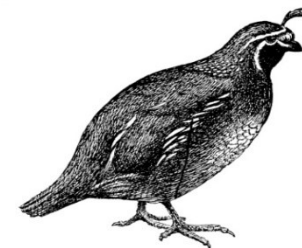

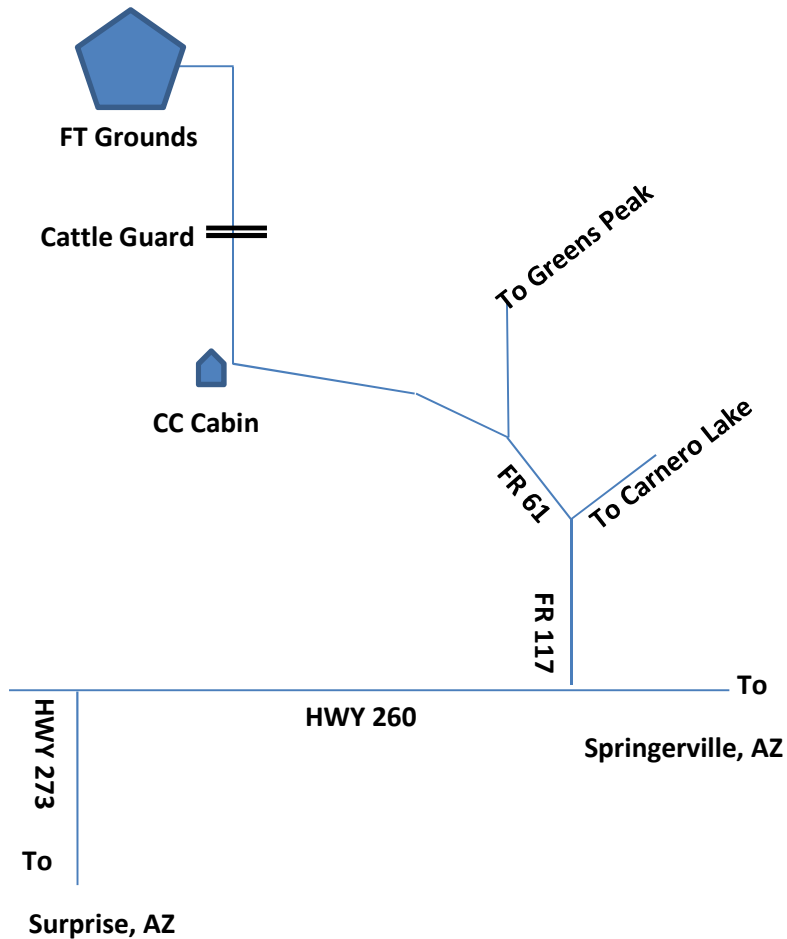
