The village has to make commitment to the bond resolution, then make decisions based on the grant received. 1980s last time grant options this size. If we receive funding this year, have to wait five-years. There will not be any additional engineering fees unless significant changes in grant received. 60% possibility of funding at this time. The water tower will be happening.

- 1- Bare minimum what has to be fixed right now
- 2- Water tower, back-up generator, additional water line into lake

\$3 million is the cap available for the grant.

Would need to keep it plowed. The electric is ready to be hooked in and used for them. Would need both gas and diesel fuel.

Streets Wes: All the trees are down and gone. Talked with Mike Covert regarding moving a curb.

Need to bid out project manager for SRTS project.

Stumps had to fill in a few spots.

Replaced culvert at Rolosons' on Mechanic Street.

Glass Magnolia had Frank Palmer come in and he opened the culvert. Work will be done over summer and into the fall.

Main Street, West Ave and Cayuga St have been swept by the state.
