Free Meals for CCA Students "Grab and Go"

As of Monday, March 23, the Clear Creek Amana School District will be offering free meals for any students and families who need this service.

The CCA food service and transportation staff will hand out lunches and breakfast to-go foods from 11:30 a.m. until 12:30 p.m. Monday through Friday at designated locations. This is free and available to ALL students.

To help the staff and volunteers know how many lunches to provide, please go to the CCA webpage and look for the COVID response banner. Or call the CCA food service office at 319-828-4510 and speak with director Debbie Klein.

Volunteers will be driving to these locations, parking in a visible area and handing out the meals to students or family members. In the Amana Colonies meals will be handed out in the Amana Elementary parking lot.

Other nearby locations for meal pickup: The Casey's in Tiffin (north side of the parking lot), the Little Clippers Daycare Center (south side), Sleepy Hollow RV Park in Oxford, Northbend Elementary, Clear Creek Elementary and Western Hills, (entrance). See the CCA webpage for the entire list of meal pick-up spots.

At this time, the schools are expected to be re-open April 13.

IEDA Resources for Businesses Impacted by COVID-19

The Iowa Economic Development Authority has posted a number of resources for small business owners to help them keep informed and direct operations at their own shops and businesses.

To access all the information being made available go to the traveliowa.com website and look for the COVID-19 Resources for Tourism Partners. This includes information regarding Small Business Administration (SBA) loans should Iowa County be designated a federal disaster area due to the virus and its disruption to business. The entire state of Illinois and some counties in Iowa on the Illinois border have already been so designated by the federal government/ SBA.

The IEDA site offers links to the Center for Disease Control (CDC) webpage with specific guidance for business owners on updated strategies and recommendations that can be implemented now in response to COVID-19.

The Iowa Economic Development Authority has posted a link to the Iowa State University Center for Industrial Research and Service that includes checklists for protecting your business from COVID-19, a checklist for screening employees and a great deal more, including links to the Johns Hopkins Global COVID-19 watch page.

Tourism in the State of Iowa and in Iowa County

In 2018 travelers spent \$8.99 billion in Iowa on gas, lodging, meals, recreation/ entertainment and retail shopping. That's a 5.8 % increase over 2017 according to the Iowa Economic Development Authority.

Here's more according to their 2018 report:

- Total payroll income received by domestic travel-generated employees and workers was over \$1.4 billion in 2018.
- Traveler spending directly generated 70,200 jobs in Iowa during 2018. A ten percent increase over 2017. This 4.4% of the total non-farm employment in 2018.

In Iowa County alone, domestic travelers spent \$46.76 million in 2018. Expenditures in order of size – gas, lodging, food, retail and entertainment.

Iowa County ranked 26th in the state (out of 99 counties) in total travel-related expenditures. The top counties were Polk, Linn, Scott and Johnson Counties.

Here are the numbers for Iowa County:

- Expenditures in millions: \$46.76
- Tourism related job payroll in millions: \$7.42
- Employment in thousands: 0.43 (430)
- State tax receipts in millions: \$3.20
- Local tax receipts in millions: \$0.72 (\$720,000)


COVID-19 Updates – Store Closures
