Westmoreland City Council
Special meeting minutes #2
May 6, 2021

The Westmoreland City Council met on May 6, 2021 following their goal setting meeting at the Community Center for the purpose of discussing street improvements.

Governing Body members present: Mayor, Mark Goodenow; Councilmembers, Mark Jack, Jim Smith, Waide Purvis, Jeff Rosell and Ashley Rice.

City Staff present: Maintenance Supervisor, Robert Krohn and City Clerk, Vicki Zentner.

Mayor Goodenow called the special meeting #2 to order at 7: 50 PM.

Councilmember Rosell stated that the city still was under a contract with Hall Brothers for the rest of the contract from March 2020 for overlaying city streets that was put on hold due to the recent pandemic. He stated that he felt the council needed to consider honoring the rest of the contract with Hall Brothers this year.

Maintenance Supervisor, Krohn, stated the following streets would need to be considered having the sealant laid down this year as the finalization of the contract with Hall Brothers:

- All of 2nd Street
- All of 4th Street
- 6th Street from Oregon Trail Drive to Cochrun and the portion of 6th and Campbell Street to the dead end
- All of North Street between North Walnut and 6th Streets
- Skene from South Walnut to the dead end

Councilmember Rosell stated that Hall Brothers had indicated they would not hold the city to the original contract in his conversation with them.

Councilmember Purvis stated he felt the city should still do the streets listed above as originally planned.

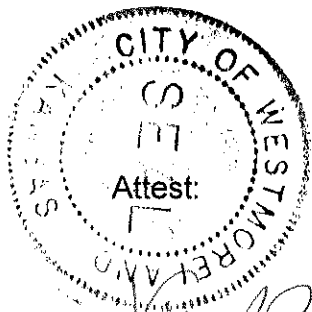
Krohn stated that the overlay would only work on those streets that were in good condition and that the cost would be up to \$47,000.00. He also stated that some patching would need to be done before the overlay could be laid, with a cost of approximately \$5,000.00.

Councilmember Rosell moved to overlay the above-mentioned streets up to \$47,000.00 with an additional cost for patching up to \$5,500.00. Councilmember Smith seconded the motion. The motion passed five (5) ayes to zero (0) nays.

There being no further discussion on the street improvements, Councilmember Purvis moved to adjourn the meeting. Councilmember Jack seconded the motion. The motion passed five (5) ayes to zero (0) nays.

Mayor Goodenow declared the meeting adjourned at 8:00 PM.
