Meeting NREMT NCCP Standards

National Registry Items for Discussion

- The new recertification procedures have been developed and are ready for implementation. They will follow the NCCP standards for National Registry and will be in a modular format. They are complete for EMR, EMT, and Paramedic. Currently EMSAC has a team building the teaching material to accompany the policy. There will only be one approved recertification for each program respectively state-wide.
- We are also putting together an online offering for each of these. Ben Tacy will be chairing the EMSAC committee
 to develop the online components.
- These programs can only be taught in 4 hour increments if done in a classroom setting. This means that an EMT recert will be put in CIS as separate modules. (i.e. EMT Recert Module I, EMT Recert Module II, etc.) This will also allow individuals to attend multiple classes if needed.
- That being said, we recently met with National Registry and they have offered to grandfather <u>all</u> WV EMS providers into the system without retesting and regardless of whether or not you ever obtained a National Registry Certification. This would allow WV to adopt the Mark King initiative and follow National Registry as the sole source for certification/recertification. The state tract would be eliminated from this point forward and we would simply follow the standards that we were already planning to implement January 1, 2018. Those WV individuals that have never taken National Registry would NOT receive a National Registry certification but instead would have a National Registry account created, submit their recertification material online just like everyone else, and they would receive a voucher card stating they completed all material required for certification. Individuals who had a National Registry certification at any point in their career would simply be reinstated in good standing.

The argument will be this, "We created a State tract because people were failing National Registry". In actuality, the pass rate on the initial State exam is mirroring the results of National Registry. The proof is in the numbers.


Should we go this direction, the system is cleaned up significantly and streamlined. WVOEMS would still provide a four year State certification card but individuals would be required to recertify every 2 years through National Registry to be eligible for State certification.

- In 2018 we are planning to release an enhancement to the NREMT website that will allow individuals to enter in state specific course information directly into their NREMT transcript. Authorized state officials will have the ability to run a 'completion report' indicating who completed the training NOTE: The NREMT will not restrict an individual's ability to obtain a NREMT certificate if a state 'required' course is not entered, as long as the individual meets the NREMT Requirements.
- There would be no recertification exam for EMT's as we know it today. There would, however, be a scenario based protocol focused exam implemented for EMT, ACT, and Paramedic.
- Currently we are prepared to release the new recertification policy January 1, 2018 with the State tract included. If EMSAC and MPCC decide to adopt the Mark King initiative and eliminate the State tract and consequently streamline the process, the implementation date will be pushed to April 1, 2018. There will not be a grace period either way. Those currently holding a four year recertification card will be required to follow the new policy effective immediately.



According to National Registry records (as of January 2017), West Virginia has over 12,026 potential candidates who would qualify for the Mark King Initiative, re-entry program.




National Average Performance

This chart is a visualization of the performance of programs in your state relative to the national average. In the chart, each bar represents all of the programs in your state for the specified level. The portion of each bar in blue represents the number of programs in your state that are high performing, and the portion in gray represents those that are low performing. For this chart, high performing

is defined as those programs with a pass rate at or above the national average pass rate. Low performing is defined as those programs with a pass rate below the national average.


In 2016, the national average pass rate for EMT programs was 68 percent, and the national average pass rate for paramedic programs was 71 percent.





I-99 Program - (Need Discussion)

- The I/99 level will be sunset at the NREMT on December 31, 2019.
- After 2019, the NREMT will not administer I/99 exams
- NREMT registrants at the I/99 level will either transition to a Paramedic or they will be automatically reverted to an Advanced-EMT
- States as always maintain the ability to license an individual at the I/99 level.
- Many states have implemented a grandfather clause: individuals may maintain I/99 at the state level.
