

## PREPARATORY SERVICES

You may elect to request one or more of the following services if your company has developed a Management System based upon the QMS or EMS ISO requirements and wishes to determine whether the requirements have been adequately addressed prior to commencing the Registration process.

### INTRODUCTORY VISIT

This service is designed for those companies who wish to familiarize their personnel with the ISO requirements; the Registration process and the benefits of achieving ISO Registration.

Fees - \$700 per half day, \$1,300 per full day, plus expenses.

### PRELIMINARY EVALUATION

A written analysis of documentation is available for those companies which have prepared a documented Management System and wish assurance that their policies and procedures meet the applicable requirements of the elected ISO 9001 / 14001 Standard.

Fees - \$725 per half day, \$1,350 per full day, plus expenses.

### PRE-ASSESSMENT AUDIT

An abbreviated Registration Assessment Audit, including a full document review and an abbreviated on-site audit is available for companies who wish to afford their employees an overview of the audit process. A complete written analysis, including needed Corrective Action, is provided.

Fee - \$1,350 per auditor day

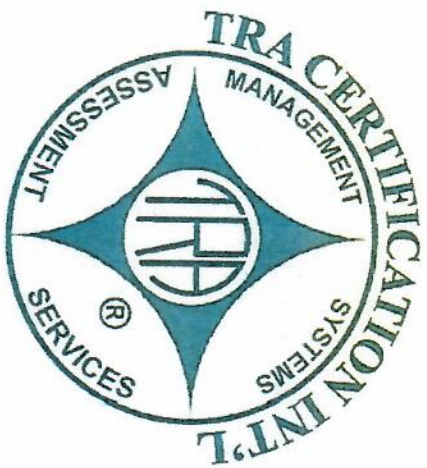

Factors which affect Assessment fees:

- Number of Sites
- Standard to which Assessment is Conducted
- Physical Size of Facility(ies)
- Number of Employees
- Organizational Structure
- Product and/or Service Range
- Off-Site Activities which must be Assessed
- Results of Previous Assessments (*i.e. Number of Non-conformances Noted*)
- Extent of Process Automation
- Complexity and/or Completeness of Documentation
- Requirement for Technical Expert Services

# REGISTRATION SERVICES

**Application:** A client information form should be completed when you have decided to begin the formal pursuit of Registration. This form provides the necessary information to allow development of a detailed proposal for the Registration.

**Preliminary Site Visit(s)** to perform an initial inspection of the facility and observe actual operations are sometimes necessary for the purpose of more clearly defining the number of Auditor Days which will be required for the Registration Assessment.

**Quality System Document Review:** your Quality System Documentation (normally in the form of a Quality System Manual and associated Procedures and Work Instructions) must be reviewed for adequacy in preparation for the audit procedures.

**Pre-Assessment Audit (Optional)** are available to familiarize your personnel with the audit procedures and to provide an indication of your current status in relation to applicable ISO requirements.

**Stage 1 Assessment:** Audits are conducted to evaluate your performance with all requirements of the chosen ISO Standard.

**Stage 2 Assessment:** Upon successful completion of the Stage 2 Assessment (Registration) Audit, you will receive Registration, be added to the published list of firms with Registered Quality Systems and receive a certificate attesting to your registered status, subject to successful maintenance of your status as specified below. Certificates are valid for a period of three years, subject to Surveillance Audits as described below.

**Registration Maintenance:** After issuance of your Registration, maintenance services are provided as your program needs change and your system must be revised to reflect the changes. Maintenance services also provide continuously updated Listing in the TRA Certification Directory.

**Surveillance** audits are provided each year during the three-year period of Registration to verify your continued compliance with applicable portions of the ISO Standard to which you are registered.

## NOTES:

1. All fees are due and payable upon completion of services provided.
2. Fees do not include actual travel and living expenses. TRA Certification policy, travel time is normally not charged and travel is via the most economical means available. Lodging is minimum rate rooms at non-luxury hotels or motels, with a reasonable allowances for meals.
3. Rates are reviewed periodically. All applications and requests for quotations are processed at the rates applicable at the time of quotation.
4. Activities which consist of less than a full day are billed in two hour increments at a rate of \$168.75 per hour.
