CALL TO ORDER and ROLL CALL

ANNOUNCEMENTS AND PUBLIC COMMENT. Trustee D'Andrea stated that due to the COVID 19 pandemic the Board is still operating under the temporary rules that were ratified at the April meeting and posted on the agenda. Jason Fowler advised that there were no emails with public comment and there were no members of the public on the conference call or in attendance at the meeting.

3. Consideration and Approval of Proposal from Huddleston & McBride Professional Land Drainage Services for Construction of Drain Tile for West Irrigation Area.

The Board discussed the Huddleston proposal. Radovich stated that the contract, among other items, must comply with the Prevailing Wage Act and these additional provisions could be contained in an addendum to the contract. Radovich also stated that the competitive bid process under the District's policy needs to be waived due to the urgent nature of the project.

Upon Motion of Trustee Hammond to approve the January 29, 2021 Huddleston & McBride proposal dated January 29, 2021 in the sum of \$160,605.60, with Alternate Route A in the amount of \$24,925.20, subject to legal counsel adding provision for insurance, prevailing wage; and due to urgent nature of project waiving competitive bids, second by Trustee Dougherty.
