 - 4.) Management shall deem the terms and conditions of the Lease as in good standing if all terms and conditions of the Lease are upheld by Resident and/or Subletter and all other parties to the Lease.
 - 5.) All Guarantors represent they have reviewed the Lease or have chosen not to and in either case agree to uphold its terms and conditions on behalf of the Party or Parties for which they have agreed to be a Guarantor
 - 6.) All Residents on the lease must reply to an email that Management will send expressing their consent to this sublet agreement in order for it to be valid.
 - 7.) Rent is due on June 1st for the fall semester and November 15th for the spring semester.
 - 8.) Please note: Do NOT transfer funds between Resident and Subletter. All monies should be paid to Management. Security Deposits should be made payable to "HSPM".
 - 9.) Rocco J. Dragani, Manager, must sign this agreement in order for it to be valid.
