Lab Charged with Identifying Remains of Missing Servicemen Being Rented Out as Movie Set & Bleated Announcement of the Release of Sgt. Bowe Bergdahl By Carol Anne O'Donnell (708) 246-1204

The following information is taken from the Nov. 23, 2013, Bits 'N Pieces, the publication of the National Alliance of Families:

"This one left us shaking our heads in a combination of disbelief and disgust. Apparently, the laboratory charged with identifying the remains of missing servicemen at the Joint POW/MIA Accounting Command in Hawaii recently rented out as a movie set. While POW/MIA families wait for remains identification, the lab closed for at least a day as Hollywood moved in. The stupidity of this decision put the lab's accreditation in jeopardy. Bill Dedman, an investigative reporter with NBC News, explains it all in an excellent article titled, 'Pentagon Lab Slow to ID Human Remains Has Time to Shoot Bradley Cooper Movie."

"We excerpt the following from the Dedman article: 'A unit of the U.S. Department of Defense, already under fire for faked public ceremonies and delays in identifying the remains of American servicemen and women, found time earlier this month to hand over part of its lab to Hollywood. The lab where human remains are usually examined was used to shoot a romantic adventure starring film heartthrobs Bradley Cooper and Rachel McAdams.

The movie company used Building 45 at Joint Base Pearl Harbor-Hickam in Honolulu, shooting for one day in a secure lab where the remains of possible Americans killed in action are usually analyzed by the Central Identification Lab, a unit of the Pentagon's Joint POW/MIA Accounting Command, known as JPAC. The lab stores about 1,000 cardboard boxes of remains awaiting identification. Although the glass-walled room usually has skeletons and partial remains laid out on the tables, a Pentagon spokeswoman said that no human remains were shown on camera and prop bones used as training aids will be shown in the movie. The movie 'had no negative impact in execution of the lab's primary mission,' said the spokeswoman, Cmdr. Amy Derrick-Frost. 'One small area of the facility was used for the one-day shoot. JPAC scientists were fully capable of continuing their very important mission of identifying unaccounted for service members from our nation's past conflicts.'

Most employees who work outside this secure lab, such as historians and other researchers, are not allowed entry to confer with lab personnel under the theory that the presence of untrained personnel could imperil the lab's accreditation, according to JPAC e-mails

reviewed by NBC News. But the lab was made available to Hollywood cast and crew. Although two lab technicians appear in the movie with speaking roles, these government employees were off duty or on leave, the Pentagon spokeswoman said. The agency did not announce the use of the lab for the movie, but the Pentagon acknowledged it when questioned by NBC News.

Who authorized the filming? And even what date did the filming occur - though employees said it was Friday, Nov. 8.

Several agency employees told NBC News that lab work was indeed disrupted as forensic anthropologists, making more than \$90 an hour, waited to be in the movie as extras or watched the crew and actors. Moving the human remains out of camera view would have taken more man-hours, the employees said.

The Department of Defense has declined to make available for interviews the JPAC scientific director, anthropologist Thomas D. Holland, or JPAC's commander, MG Kelly K. McKeague. The JPAC lab was used as a set at least once previously. An episode of 'Hawaii

Five-O,' the remake of the original TV series was shot there in 2011."

AT LAST BERGDAHL'S RELEASE

Rev. Jesse Jackson, Sr. and ex-Gov. Rod B. (They couldn't have done it without the OK of the President as it is illegal for citizens to undertake negotiations such as that otherwise.)

Veterans Benefits

Many veterans have a rather "good" idea as to the array of veteran benefits available from the U.S. Department of Veteran Affairs. Yet, many veterans are not aware of the benefits from the Illinois Department of Veteran Affairs, or IDVA.

I'll present a list of those benefits for this edition and followed by a monthly detail of each benefit. Here we go:

Veteran's Homes, Hunting and Fishing Permits, Camping and Admission Fees,

War Bonus,


Survivors Compensation,
Carthage and Erection Reimbursement,
Returning Veteran's Homestead Exemption,
Disabled Veteran's Standard Homestead Exemption,
Disabled Veteran's Tax Exemption for Specially Adapted Housing,
Tax Exemption for Mobile Home,
Disabled Veteran's Specially Adapted Housing (PH) Grant,
Disabled Veteran's Specially Adaptation (AH) Grant,
Illinois Veterans Grant,
Children's' Educational Opportunities,
and MIA-POW Scholarship.

Hey, wait? What about that "War Bonus?"

The State of Illinois grants a onetime grant for vets who have served in wartime conflicts. Those conflicts are: World War II (9/16/1940-9/3/1945), Korea (6/27/1950-7/27/1953 and received the Korean Service Medal), Viet Nam (1/1/1961-3/28/1973 & Frequent Wind 4/29-30/1975 and received the Viet Nam service medal or the Armed Forces Expeditionary Medal- Viet Nam Era), Desert Storm (8/2/1990- 11/30/1995), Global War on Terrorism, Operations Iraqi Freedom, Operation Enduring Freedom, Operation New Dawn (9/11/2001 - ? and received the one of the following: Global War on Terrorism Expeditionary Medal, Global War on Terrorism Service Medal, Iraq Campaign Medal, Afghanistan Campaign Medal).

The DD 214 must indicate Honorable or Under Honorable Conditions. Okay, how does one get the "ball rolling?" A vet can call the IDVA at (800) 437-9824 or visit www.veterans.illinois.gov. And not to worry, if you apply and received the bonus many years ago, the IDVA will surely remind you. Oh by the way, the bonus is \$100 (enough for a full tank of gas!). However, if you served in a war zone, the bonus is waiting for ya!
