AN ORDINANCE OF THE TOWN OF MARBLE, COLORADO, ADOPTING THE ICBO PLUMBING CODE, 1979 EDITION, AS PROMULGATED BY THE INTERNATIONAL CONFERENCE OF BUILDING OFFICIALS, 5360 SOUTH WORKMAN MILL ROAD, WHITTIER, CALIFORNIA, INCLUDING ALL APPENDICES AND ICBO PLUMBING STANDARDS FOR THE PURPOSES OF PROVIDING MINIMUM REQUIREMENTS AND STANDARDS FOR THE PROTECTION OF THE PUBLIC HEALTH, SAFETY AND WELFARE IN THE ERECTION, INSTALLATION, ALTERATION, ADDITION, REPAIR, RELOCATION, REPLACEMENT, MAINTENANCE OR USE OF ANY PLUMBING SYSTEM EXCEPT AS OTHERWISE PROVIDED IN SAID ICBO PLUMBING CODE, 1979 EDITION.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MARBLE, COLORADO, THAT: ORDINANCE NO._____, Series 1973____, is hereby repealed and that a new ordinance is enacted to read as follows:

SECTION 1. For purposes of providing minimum requirements and standards for the protection of the public health, safety, and welfare in the erection, installation, alteration, addition, repair, relocation, replacement, maintenance, or use of any plumbing system, the said ICBO Plumbing Code, 1979 Edition, promulgated by the International Conference of Building Officials, 5360 South Workman Mill Road, Whittier, California 90601 is hereby adopted along with all appendices and plumbing standards contained in said publication.

SECTION 2. It is unlawful for any person, firm, or corporation to erect, install, alter, add to, repair, relocate, replace, maintain or use any plumbing system in the Town of Marble, except as otherwise provided in said ICBO Plumbing Code, 1979 Edition.

SECTION 3. Any person, firm, or corporation violating any of the provisions of the ICBO Plumbing Code, 1979 Edition, as adopted in this chapter is guilty of a misdemeanor, and such person is guilty of a separate offense for each and every day or portion thereof during which any violation of any of the provisions of the ICBO Plumbing Code, 1979 Edition, is committed, continued, or permitted, and upon conviction of any such violation, such person shall be punishable by a fine of not more than three hundred dollars or by imprisonment for not more than ninety days, or by both such fine and imprisonment.

SECTION 4. Unless the context is indicated to the contrary, all references in this Chapter to the ICBO Plumbing Code, 1979 Edition, shall also include the appendices and plumbing standards contained in said publication.
