

Waiver and Agreement to Hold Harmless

Woofa~Roo Dashers All Breed Lure Coursing is an informal group of people interested in and or participate in non-competitive all breed lure coursing in Essex County. Lure coursing is a fun way to exercise dogs by doing what comes naturally to them, chasing prey! We want you and your dog to have fun, but safety is paramount to us. The undersigned is aware of the inherent risks of injury involved in dog sports, including without limitations, risks due to dog bite, the use of equipment or infectious disease. The undersigned is voluntarily engaging in dog lure coursing as a recreational activity with the knowledge of the risks of injury, death and property damage that may result from participation in dog lure coursing.

- 1. I (the undersigned) understand and agree that there are inherent risks associated with dog training and the dog sport of lure coursing and I assume full responsibility for all risks associated with my participation and hereby waiver, release, discharge, hold harmless, and agree not to hold Woofa~Roo Dashers, any of its volunteers, service providers, vendors, organizers, property owner, The City of Amherstburg, The Greater Essex County District School Board or any other participant (herein the "Released Parties") responsible to me or to my dog(s) for any injuries, illness, losses, wrongful death, damages, liabilities, damage to or loss to personal property, or expenses of any nature, (including legal fees) caused or alleged to be caused by the Released Parties' alleged negligence or wrongful acts, conducts or omissions, breaches of any expressed or implied warranties when participating in a Woofa~Roo Dashers event.
- 2. I further agree to assume the sole responsibility for and agree to waive any claims for injuries, damages to the owner (myself) and hold the Released Parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the Released Parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself, of on account of damage to property, arising out of or inconsequence of my participation in this event or activity, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the Released Parties.
- 3. Furthermore, Woofa~Roo Dashers reserves the right to refuse entry and/or eject any person from any activity sponsored by the Released Parties or its affiliates, or any property used by the Released Parties for disorderly conduct, intoxication, or lack of control over a dog(s) and stop or limit any dog's participation due to age, body condition, lameness, physiological limitations, temperament, weather conditions or any other factor that could affect the safety of the dog, other participating dogs, spectators either dog or human without refund of fees.

4. To the best of my knowledge, information and belief, the dog(s) listed below is (are) in good physical condition, at least 18 months of age, has no injuries past or present or physical problems that would preclude their involvement in lure coursing activities. I represent and certify that my dog(s) is (are) no a danger to persons or other dogs. I enter into this agreement at my own risk, and by bringing my dog(s) to a Woofa~Roo Dashers event or activity, I assume all liability and assume the risk for the dogs' conduct, safety and well-being.
