Legislative News

For decades WI has prided itself as a 'cut above' in many areas of quality. For persons who hold a license to practice their skill/ profession/ trade it has been promise to the citizens of WI that the goal is for the citizen protection. License holders are held to a level of accountability, if not met consequences can and do happen. Department of Safety and Professional Services is currently being looked at for a change in practice. Depending on the final resolve, you will be affected either as a license holder or in regards to requesting and being given a service.

In March 2017 Joint Finance testimony DSPS Secretary Gutierrez testified that DSPS license more than 370,000 individuals from 166 different professions. *Licensed* is the most restrictive type of credential. *Certificates* generally serve to provide special recognition to individuals who have met predetermined qualifications. They may be required to take an exam. To have 'registration' is the least restrictive form of credentialing. – I.e. for DSPS records having your name, address, and pay a fee.

Current legislative leaders are looking decreasing the occupations that 'need' a license to practice. This was originally brought up in the budget, then removed. Currently under the leadership of Senator Chris Kapenga is looking to introduce a bill to conduct a review of Wisconsin's occupational licenses and to establish guidelines for review of proposed licenses. Senator Alberta Darling and Rep. Rob Hutton have joined with his thinking.

Senator Kapenga is concerned with 'inhibiting' free enterprise and creating barriers to people finding work. He wants licensing requirements to be reviewed. He states his goal would to create a occupational license board with appointees, who would be tasked with reviewing every license on the books, this group would then make recommendations to the legislature on 'potential' reforms to WI licensing laws. As of this writing Americans for Prosperity have put out a press release expressing their glee with a variety of statements such as "These laws are outrageous because they effectively require Wisconsinites to get government permission slips to work for a living." AFP also speaks to license as 'barrier.' At this time there is a document identified as Legislative Reference Bureau (LRB 3040). Be watchful, of what actions, hearings, and mantra is taking place. When you go to the Beauty Salon have conversations; learn the details from people on the front line at this time.

Please note that DSPS is almost entirely a program

revenue department. This is an important aspect in recognizing not 'taking tax payer money,' keeping Wisconsin safe, and knowing persons have met the criteria to produce a safe practice for the citizens of our State. Remember what affects one: affects us all.

A nursing refresher course is designed for nurses who have not been practicing for five years or more. Courses must be approved by the Board of Nursing will be included on a listing of approved nursing refresher courses. Individual nursing refresher course participants

are required to submit curriculum only if the course is not already included on the approved course list.
