The Planning Commission meets at 6:00 p.m. on the second Tuesday each month at City Hall. Items for the Planning Commission should be submitted to the Building Department at City Hall no later than <u>2 weeks</u> prior to the meeting for consideration at the month's meeting.

The Board of Zoning Appeals meets at 6:00 p.m. on the second Tuesday each month at the City Hall. Items for the BZA should be submitted to the Building Department at City Hall no later than 4 weeks prior to the meeting for consideration at the month's meeting.

The above list of contemplated projects is NOT all inclusive, nor is it intended to be a definitive document with respect to wether approval should or should not be sought.

Homeowners should constult with Quivira, Inc. with projects that may require RC/ARB review and/or approval, and consult City of Lake Quivira, Building Department for projects that may require Planning Commission review and/or approval.

The RC/ARB meets at 5:30 p.m. on the Monday preceeding the second Tuesday each month in the Quivira, Inc. office. Items for the RC/ARB agenda should be submitted to Quivira Inc. office 2 weeks in advance of the RC.ARB meeting

Numbered Notes:

- Nearly all roof replacements are approved via e-mail. If the applicant is changing from a wood roofing material to any of the newer products
 Q-Inc asks for a courtesy application clariying what the new material and what color. Some roof replacements are mandated by inspecton before re-sale closings. The majority are approved via e-mail to avoid closing delays.

- 3. Any dock, dock site and seawall construction must go through Lake and Residential Committee for approval
