## Terms and Conditions of Use

If the hirer is in any doubt as to the meaning of the following, a representative from Steggies Soft Play and Inflatables should be immediately consulted.

### **All payments to be paid in full before any equipment is installed.**

- The hirer will, during the period of the hiring, be responsible for the supervision of the equipment, its care, safety from damage, however slight and the behaviour of all the persons of all ages using the equipment whatever their capacity, including proper supervision of children to ensure children under school age use the equipment separately to older children or adults.
- The hirer shall not use the equipment for any purpose other than that described in the hiring agreement and shall not sub-hire, use the equipment or allow the equipment to be used for any unlawful purpose or in any unlawful way.
- The hirer shall be deemed to have inspected the equipment and to have agreed that it is supplied in good condition unless he/she brings any fault to the attention of Steggies Soft Play and Inflatables when it is set up and checked by the hirer when coming into possession of the equipment. Any faults to be noted by both parties.
- The hire period, unless otherwise agreed is from delivery until        hrs or after at the discretion of Steggies Soft Play and Inflatables.
- Public liability insurance is excluded in its entirety following any claim or injury to any third party or employee whether directly or indirectly related to drugs and alcohol. Steggies Soft Play and Inflatables excludes any liability for injury loss or damage caused to any person using the equipment contrary to the terms and conditions of this contract.
- This unit has an age limit of 12 years. Please ensure no-one over this age uses the equipment. Failure to observe this limit at any time during the hire period will render the hirer liable for associated repair costs.
- **NO** food or drinks to be consumed on the inflatable, to avoid choking and mess.
- **ALL** shoes, badges, jewellery, key rings, metal studded clothes or any other sharp items **MUST** be removed. It is recommended that spectacles are also removed.
- **NO** face paints, party poppers, coloured streamers or silly string must be used on or near the inflatable, as they will permanently stain the unit. The hirer will be liable to compensate Steggies Soft Play and Inflatables in the event of any damage.
- **STRICTLY NO SMOKING OR NAKED FLAME** on or near the inflatable. This includes barbeques.
- **NO** pets allowed on or near the equipment at any time to prevent damage or fouling. The hirer will be liable for any damage or sanitisation costs incurred.
- Climbing, hanging or sitting on the walls is extremely dangerous and **MUST NOT** be allowed.
- A responsible adult **MUST** supervise the inflatable at all times.
- Ensure that the inflatable is not overcrowded and limit the numbers depending on size of children using it. If the children are bumping into each other then it is too crowded.
- Try to avoid large children and small children from using the inflatable at the same time.

- **DO NOT** allow anyone to bounce on the step or front apron. The step is there to help users get on and off.
- **DO NOT** allow users to be on the unit during inflation or deflation.
- It is advised that persons with neck or back problems do not use the inflatable.
- If the inflatable is not being used for part of the day, please switch the blower off at the mains.
- In the event of heavy rain, it is strongly recommended that the inflatable be switched off. Any wetness including bubbling can be dried with a towel.
- The blower at the back has a safety reset button. In the event it overheats or loses power, switch the blower off at the mains then switch it back on again after a couple of minutes, it should then restart. If it does not, inform Steggies Soft Play and Inflatables immediately.
- Only a responsible adult to attend the blower in case of problems. **NO** children to go near the blower at any time.
- Ensure that the vent on the side of the blower is clear at all times.
- All persons using the inflatable do so at their own risk.

These conditions of use are for the safety of all people using this equipment and it is the sole responsibility of the person hiring the equipment to ensure they are adhered to.

## Disclaimer

### **Important notice**

Provided that the equipment supplied is used in accordance with the terms and conditions of hire, those using them should do safely. However, accidents can happen. Steggies Soft Play and Inflatables can accept no liability for injuries sustained or any other loss, howsoever caused in the absence of the negligence of Steggies Soft Play and Inflatables or its employees.

As the equipment will be in the hirers possession and control whilst in use rather than Steggies Soft Play and Inflatables, any liability for injuries or other losses caused other than in the circumstances described above rests with the hirer. Accordingly it is recommended that the hirer has adequate public liability insurance covering his or her liability arising from the use of the inflatable.
