The regular meeting of the Sherman Township Board was held on august 1<sup>st</sup>, 2016 at 7:00pm at the township hall. Meeting called to order by supervisor. After the pledge of allegiance to the flag, roll call was taken: Members present: Berens, Miller, K Smalligan, Stocking, W Stroven. There was a motion by Stocking, 2<sup>nd</sup> by K Smalligan to approve the agenda. All yes, agenda approved.

There was a motion by K Smalligan, 2<sup>nd</sup> W Stroven, to approve the minutes of the July 5<sup>th</sup>, 2016 regular meeting with correction to some check numbers. All yes, minutes approved.

There was no public comment at this time.

Berens gave the treasurer's report including bills to be paid. A bill for \$779.00 was presented by Marv Deur for the cost of a zoning seminar at the end of the month. There was some discussion about a bill from Digital Core for anti-virus protection software. The opinion of the board is to pay the bill for coverage for the next year. There was a motion by K Smalligan, 2<sup>nd</sup> by W Stroven to accept the report and approve the bills including the zoning seminar and anti-virus. Roll call vote; YES: Berens, Miller, K Smalligan, Stocking, W Stroven. NO, none. Motion passed.

Clerk reported that the primary election is august 2<sup>nd</sup>.

Under supervisor's report, Miller updated the board on fire run billings and collections. He reported on the Newaygo Co solid waste committee wanting to add Wayne county as a site for solid waste for Gerbers. He also reported that Recycle of Newaygo county is struggling to remain in operation. They are asking for donations. There was a motion by K Smalligan, 2<sup>nd</sup> by K Berens to donate \$500.00 to Recycle of Newaygo co. Roll call vote; YES: Berens, Miller, K Smalligan, Stocking, W Stroven. NO, none. Motion passed.

W Stroven said that the MTA will hold a seminar in Big Rapids on Oct 25<sup>th</sup>.

There was no report from the planning/zoning commission at this time.

Miller said that he had not received any reports of fire runs from Fremont.

Al Smalligan gave an up-date on PZC. There were questions about some wording in the proposed changes to the zoning ordinance concerning mining. PZC to look at the wording and bring back to the board. He also informed the board about the Shrock request for a variance. He said the Mr Shrock did not directly answer questions and that a number of neighbors spoke against the variance, no one in the audience spoke for it. Karen Berens asked if Mr Yost could come back with a modified plan. Al Smalligan said yes, he could. She also asked if the PZC could modify the ordinance to help future requests. She asked if we are discriminating against the Amish. K Smalligan said that modifications have taken place. Al Smalligan said that the zoning is for the good of the township. Marv Deur said that when the ordinance was adopted in 1996, there were no Amish families in the township. He said the ordinance is a living document and can be changed. Ken Smalligan said that there should be an yearly inspection of the variances. Miller said he works with applicants and tells them what documents are needed. He said other variances were granted where buildings were used as storage. He said procedural changes are needed. If Mr Shrock came back with a plan on using the building with part of it storage, it would be considered. Al Smalligan said that the PZC will look into changes.

Miller asked Al Smalligan about the Cruzan building on 48<sup>th</sup> st. Miller said that the zoning map was wrong and that the Cruzan property was zoned commercial, not ag. The strip from Croswell to the medical facility was changed to ag in 2004 but the Cruzan property stayed commercial.

The building inspector gave his report. He had written 1 permit and had 4 inspections.

Miller updated the board on zoning permits and dilapidated building violations. He said progress is being made

on some of the violations.

Chenard gave the report on the sewer authority. The new truck will be delivered by the end of the month. They are working on the asset management plan recommendations.

S Stroven said that he would not be in favor if the solid waste changes proposed if it meant that Wayne county could ship waste to Newaygo county. He also asked the board to pass a resolution to not pursue collecting property transfer tax fines. He said it would cost more to collect the fines that we would get. This will be considered next month. He also said that he had gotten a call on the Cruzan property.

Two bids were received for the well at the cemetery;

Kuhns: \$7,873.00 Lauritzen: 7.373.00

There was a motion by K Smallgan, 2<sup>nd</sup> by Stocking to approve the bid from Lauritzen. Roll call vote; YES: Berens, Miller, K Smalligan, Stocking, W Stroven. NO, none. Motion passed.

The White Cloud fire district is still working on getting warning lights for the corner by M 37. Gary Smalligan said that the fire authority and the fire department were looking into having one combined audit. There was nothing new from the Fremont fire department.

Miller said that he would contact the person seen dumping waste into the dumpster at the park. Lee Hoppa said that the sign by the dumpster says "For park use only". Miller also said that he was still working with Maike on the new web site.

Under public comments, Gary Smalligan said the code book uses the term "commercial", it does not use "manufacturing". Manufacturing is under commercial. Ken Smalligan thanked Karen for the discussion about zoning. Lee Hoppa asked if the deposit for rental is kept to ensure that there is no damage. He said he had to repair several chairs.
