



**PARENTS CODE OF ETHICS
(MANDATORY FOR ALL PARENTS/GUARDIANS TO READ, INITIAL & SIGNS)**

I hereby pledge to provide positive support, care and encouragement for my child participating in the Camden Clock Chasers Track & Field Program by following the Code of Ethics.

1. ___ I will encourage good sportsmanship by demonstrating positive support for all athletes, coaches, officials, other parents and opponents at every practice, meet or any other C3 event.
2. ___ I will place the emotional and physical well-being of my child and all C3 athletes ahead of any personal desire to win.
3. ___ I will insist that my child participate in a safe and healthy environment.
4. ___ I will provide support for coaches and officials working with my child to provide a positive, enjoyable experience. As a parent, I am required to stay outside the track area during meets and practices. Coaching will be left as a job for the coaches.
5. ___ I will insist that my child treat all athletes, coaches, fans, officials and opponents with respect regardless of age, sex, creed or ability.
6. ___ ***I will pay all Club fees and dues in a timely manner, with the understanding my child will not be able to participate if payment is not made in full.***
7. ___ I will present the Club with a copy of my child's birth certificate prior to practicing with the team.
8. ___ I understand I will be required to volunteer at TWO meets during the season. Volunteer opportunities are available on a sign-up basis - dates and duties are first come/first served. If you have not volunteered proactively, you will be asked to fill slots as needed to fulfill your parental requirements.
9. ___ I will support and participate in C3 fundraising efforts by working or soliciting funds in whatever capacity that may be required.
10. ___ I will properly supervise my athlete(s) at all C3 functions that I attend. If I am unable to attend a function, I will ensure my child is being supervised by a designated responsible person, and such is communicated to C3 staff.
11. ___ I will help enforce curfew, by having my child in his/her room by said time, in the event of overnight stays.



12. ___ I will notify a coach and or staff member in advance whenever my athlete(s) is not able to attend a track meet.
13. ___ I will conduct myself in a peaceful and orderly fashion at all times during C3 events and refrain from using profanity, displaying disorderly conduct and/or inappropriate behavior.
14. ___ I will be financially responsible for any items either broken, removed/stolen, or damaged in the hotel or on a bus while on a travel meet.
15. ___ If I am unable to attend a meet, I will supply my athlete(s) with a lunch and/or sufficient amount of money for him/her to eat during the meet (at least \$20.00).
15. ___ There will be a Travel Policy for away meets. I will adhere to the terms of the Travel Policy.

"If you cannot abide by these rules, then please do not register your athlete(s) for this Club".

I understand that failure to comply with any of the rules could result in a length of suspension, no less than one week, up to possible permanent suspension from the Club. I understand that if I am suspended, I cannot participate in any activity/events involving the Camden Clock Chasers Track Club until the suspension has ended.
