## HẠM ĐỘI (GIGANTIC) CHALLENGE RELEASE OF LIABILITY, HOLD HARMLESS, AND INDEMNIFICATION AGREEMENT

The undersigned (the "Participant") understands and acknowledges that participation in the HAM ĐỘI (GIGANTIC) Challenge (the "Promotional Event") involves a risk of personal injury and is fully aware of the risks involved in participating in such Promotional Event.

Participant acknowledges that he or she is voluntarily participating in the Promotional Event and hereby voluntarily assumes all risk of loss, damage, injury, illness, or death that may be sustained by him or her as a result of his or her participation in such Promotional Event. In consideration for allowing Participant to participate in the Promotional Event, Participant, on his or her own behalf, and on behalf of all other persons claiming by, through or under him or her, hereby releases A&K- PHO96, LLC., its subsidiaries, and, as applicable, as well as their respective officers, directors, employees, agents, independent contractors and successors and assigns (referred to hereinafter as the "Company Parties"), from all rights, claims and actions, including claims for personal injury of a Participant, death of a Participant and/or damage to property of a Participant, arising out of the Participant's participation in the Promotional Event, whether or not said injuries, death or damage were caused by the negligence or other acts or omissions of the Company Parties.

6. Other than noodle, during the HAM ĐÕI (GIGANTIC)'s Challenge, Participant cannot use any other food, including, but not limited to: Beansprout, Basil, Culantro, lime, Jalapino and Sauces.
