(A)**Testing of sediment** – (The Bd has asked the LC to oversee sediment testing. Elayne will contact Larry Butlein, who took samples two years ago, to ask if he can take samples again from the sediment *and* from Peck's land. If he agrees, volunteers will have to pick up the equipment from the lab in Albany and also drop off the samples after they are taken.

Lois will also ask Allied how much it would cost for them to take the samples and analyze them.

- (B)Contouring sand bar The Board decided not to pursue contouring the sand bar because it would **not** increase the depth of the lake, and would most likely make a larger swath of the lake shallow
- (C)**Dam** The LC recommends that Rosina, who was not present at this meeting, may want to speak to the Bd about C.T. Male.

3. Observations Post-Nautique and copper sulfate treatments

LC will begin to write a yearly "After-Treatment Report" including observations about the lake as well as temperature, rain, sun. No one officially assigned this task.

Because the surface of the lake is scummy following treatment for milfoil (Nautique), Allied recommends follow-up algaecide treatment as soon as possible. We all agree.

4. Partnerships for grants

The LC tries, whenever possible, to obtain government grants to help pay for costly treatments to maintain a healthy lake. To obtain such a grant we have learned that we must partner with a governmental agency. We have learned that we cannot partner with NYS Soil and Water. Debby will contact Jeanne Mettler on the Copake Town Bd to explore the possibility of partnering with the Town of Copake. The next opportunity to apply for a NYS grant is June 2016
