Praised sewer rate increase as "steady as you go" and not waiting until a large increase would be needed. Harder on all that way. Decker suggested general fund cash flow be at \$150,000. Decker stated everything looked good. Day suggested looking at transfers concerning cash flow.

Decker said State focuses on compliance whereas this audit focuses on financial. Numbers being true and accurate and consistent year to year. All looks good.
