TREASURER'S REPORT

We are still doing well financially through the end of June. We are under budget in all expense categories except for General and Administrative costs, where we are still over budget mainly due to having paid our liability and bond insurance premium for the full year. However, the overage has been going down as the year progresses. Overall, we are under budget by about \$18,309.00. Our operating cash, minus current liabilities, is still in the \$68,000 range, so we are in good shape in that area as well. I'm expecting continued cost savings for the rest of the year, but not quite as much as that in the first half, as our summer and fall months usually generate more expenses, particularly in the landscaping category.

BACKFLOW INSPECTIONS. COURTESY OF THE HOA

As most of you have probably noticed, all of the backflow devices in Chantarelle underwent the required annual inspections this past May. As mentioned in previous newsletters, the HOA board of directors had voted to arrange and pay for these inspections as a group event rather than burden the individual homeowners with setting up the inspections on their own. Not only did this save Chantarelle homeowners time and trouble. it also saved each homeowner money. Having the inspections done as a one-time group event confined and indoor spaces. cost the HOA \$25 per device, or about \$2.10 per homeowner per month. On the other hand. had it been left up to each homeowner to arrange and pay for the inspections on their own, the cost could have ranged anywhere from \$50 on up. The board believes we can absorb this extra cost this year due to the extraordinary events that have led to lower expenses so far this year. Owing to the minimal cost per homeowner. the board will try to absorb this cost on a year-by-year basis. However, be aware that this extra expense, in conjunction with other increases due to normal inflationary factors, will eventually have to be passed on to homeowners in the form of a dues increase.

SAFETY & WELFARE

There are so many aspects of the coronavirus pandemic over which we have no control. There are, however, measures

that we all can continue to take to ameliorate the situation for ourselves, our families, and our friends and neighbors. Here is some advice from AARP.ORG:

- Continue to practice social distancing. Staving at least six feet away from others is especially important for people who are at higher risk of getting very sick, such as older adults.
- Avoid close contact with people who are sick, even inside your home. If you must go out in public, wear a mask.
- Avoid crowds, particularly in
- Wash your hands often, for at least 20 seconds — or use an alcohol-based hand sanitizer that contains at least 60 percent CARS, CARS, CARS ... alcohol — especially after you've been in a public place or sneezing, coughing or blowing your nose.
- Avoid touching your eyes, nose and mouth with unwashed hands.

- Monitor your health. Be alert for symptoms such as fever, cough, shortness of breath and other signs the CDC has identified. If symptoms develop, take your temperature and follow CDC guidance.

REMINDER TO OBTAIN ACC APPROVAL

Exterior changes to homes, windows, fences, garage doors, paint colors, gates or roofs must be approved by the Architectural Control Committee (ACC) BEFORE work begins. Request forms are available in the clubhouse, online at Chantarelle.org, from ACC committee members and from Strong Management. Completed forms must be submitted to the ACC at least 30 days before the start of the project to allow time for review and follow-up. When projects involve common area fences shared by both the homeowner and the HOA, additional procedures mentioned in the May 2012 "Report on Common Area Fences" must be followed. including obtaining multiple bids. An additional item has been added to the ACC approval process regarding the display of flags. The American Stars and Stripes, individual state flags, and seasonal/ holiday flags may in most cases be flown without permission. Permission to fly other flags must be requested from the ACC. Adhering to ACC rules will ensure the continued coherence and beauty of the Chantarelle community, while at the same time maintaining the quality of life and desirability of residing here.
