Update on Items from 2022 Minutes:

1) Risk Management and Liability

Playground Signage

Upon recommendation by the insurance provider for the RM of Grayson signage was added to the playground and beach area stating they are "use at own risk" and that there are "no lifeguards on duty".

Swimming Area

Upon recommendation by the insurance provider for the RM of Grayson buoys were procured and installed to demark the swimming area and discourage boat traffic. Following installation of the Buoys we received a letter from Transport Canada stating they did not meet requirements. To reach compliance the exterior corners of the swim area must be marked with buoys at least 15.25 cm wide and at least 30.5 cm high. These buoys also need to be marked as "PRIV" and "Hamlet of Sunset Beach". The Buoys will not be installed for 2023 until we have compliant Swim Buoys procured and available.

2) Vote on amendment to Bylaw Section 8.4.6 – 2 RV's on a lot

The vote was in favor of allowing 2 RV's on a lot with no permanent residence.

For	Amend the Bylaw to allow one (1) camper on lots with a Permanent Residence and two (2) campers on lots without a	108
	Permanent Residence (empty lots), designating one (1) camper as their Primary Residence.

As such, the RM is the process of revamping the entire Zoning Bylaw (including the 2 campers per lot) which is unfortunately a lengthy process and requires Ministry approval. This process has not been completed to date, but the current zoning bylaw with respect to RV's will not be enforced while this change is in process.

3) All invoices for the Hamlet of Sunset Beach must be preapproved.

With respect to our motion passed last year the Organized Hamlet of Sunset Beach must approve all invoices, we received the response below from MLT AIKINS on behalf of the RM of Grayson.

In your email dated March 6, 2023, you made reference to a motion carried by the Hamlet board on June 11, 2022, requesting that any work performed on behalf of the Hamlet be pre-approved by the Hamlet. We would note that the June 11, 2022 motion was in relation to snow removal and the clean-out of a culvert, which is categorically different than the enforcement of the Zoning Bylaw.

At any rate, organized hamlets are subservient bodies to the RM and have no authority to adopt bylaws and resolutions of their own, but may only make representations to RM council.

Furthermore, pursuant to ss. 73 to 76 of The Municipalities Act (the "Act"), a hamlet's jurisdiction is limited to the installation of a waterworks or sewage system, the construction of a power distribution system, the provision of streetlights and sidewalks and the provision of certain services. The Act does not confer jurisdiction upon the Hamlet to enforce the Zoning Bylaw and therefore, the Hamlet does not have the authority to pre-approve any decisions regarding the RM's enforcement of the Zoning Bylaw.

2. Legal Fees

The RM of Grayson informed us on June 28th they had passed the resolutions below:

Hamlet Budget 146/22: That Council request the Hamlets of Exner's Twin Bays, MooseBay, Greenspot and Sunset Beach add legal fees to their 2022 budget.Carried

Hamlet Legal Fees

147/22: That in the event one of the Hamlets incur legal fees, the R.M. of Grayson No.184 (R.M.) will pay the first 10,000 on behalf of the Hamlet and then the expense will be split 50/50 thereafter. Should the Hamlet's legal expenses exceed their budgeted amount, the expense will be paid out of any budget surplus before the R.M. considers financing options in the event of a shortfall. **Carried**

On behalf of the Hamlet of Sunset Beach I submitted a formal request for additional information with respect to these charges.

In response, I received a letter from their legal firm, MLT AIKINS, stating that the RM had paid legal fees for the enforcement of s.7 of the RM's Zoning Bylaws No 2004-02. The letter further stated that the legal fees were all for fees pertaining to services in relation of s.7 of the Zoning Bylaw provided between January and December of 2022. The fees were invoiced to the RM on January 31, February 28, March 31, May 31, June 30 and July 31 of 2022.

At the annual meeting between the Hamlet Boards and the RM in March I formally requested detailed information on the legal services that were provided to ensure they were all for services provided with respect to s.7 zoning bylaw enforcement within the Organized Hamlet of Sunset Beach.

The RM's response was received May 25th, see below.

Request from Earl Gosick of Sunset Beach 129/23: In reference to Resolution 103/23, that Council respond to Earl Gosick in accordance to the direction provided by the R.M. of Grayson's Legal Counsel and further remind Mr. Gosick that the R.M. of Grayson including the Hamlets of Exner's Twin Bays, Greenspot, Moose Bay and Sunset Beach receive an annual audit performed by Baker Tilly Canada, a reputable association of Chartered Accountants and Chartered Professional Accountants. **Carried Unanimously**

In regard to the legal services associated with s. 7 of the Zoning Bylaw, it is the R.M. of Grayson's Legal Counsel's view that the invoices, particularly the narrative associated with each time entry, would reveal communication protected by privilege. Therefore, the request is denied on the basis the legal

invoices are subject to solicitor client privilege and will not be disclosed.
