## JOB TITLES FOR STAFF INTERPRETERS

## Introduction

The article arising out of this study of court interpreter compensation did not include information about related data such as position titles. Since the data were collected, the authors want to make them available here. This file provides a summary of the findings, together with some aggregated tables of data, followed by tables that list all the position titles that were documented during the research project.

## **Summary of Findings**

There is widespread diversity in how courts denominate the job title levels for staff interpreters. With respect to the trainee titles, every one of the eight jurisdictions using this level of interpreter has a different title, as do the master titles in the three jurisdictions with that level. The designations of entry-level titles vary almost universally among state courts and in a great majority of county courts. Manager titles are extremely diverse in all types of courts and even within some court systems (notably USDCs and California). To some degree this is a function of the different kinds of positions that are included in this category. For example, many of the positions included here are courts with a single employee who interprets and also coordinates the court's interpreting services. Even if these positions were separated out, though, the basic finding of widespread diversity would still hold given the scarcity of identical titles among this level of interpreters.

As Table A shows, the greatest level of consistency in nomenclature of job titles appears in the entry titles for the USDCs, the California courts, and city-municipal courts—but even in those systems there is some variation.

Note: Totals are not appropriate for this table as the same title is often used by different types of court as well as for different levels. For example, Court Interpreter I is a trainee title in one state court, an entry title in another state court, and a trainee title in a county court.

The most frequently used title for the entry level position is "Court Interpreter," which is used in 36 different courts. Furthermore, there are about twenty-five additional courts that use

some variant of that title such as "Certified Court Interpreter," "Court Interpreter-Certified," "Court Interpreter I," "Official Court Interpreter," "Staff Court Interpreter," "Court Interpreter-Spanish." The second most frequently used title is "Interpreter" and its many variations that did not include the term "Court": "Foreign Language Interpreter-Spanish," "Interpreter I," "Interpreter II," "Lead Interpreter," "Senior Interpreter," "Spanish Interpreter," "Spanish Staff Interpreter," and "Staff Interpreter." There are some thirty instances of titles using "Interpreter" without the additional word "Court." Only one title has neither "Court" nor "Interpreter" in it: "Certified State/County Funded."

With respect to the other three levels of staff interpreters, the nomenclature is so diverse that there are no titles that are used in common in more than a handful of jurisdictions. This is true both across all types of court as well as within many of the same types of court (e.g., there are 12 different titles for managers out of 16 USDC's that report such titles).

As to dual titles, there are ten different titles in use. One appears at a state level (and that one, while it is a dual title officially, is not functioning as one) and another in a municipal court. Eight titles are used in five county courts. None appear in the USDCs or California courts. One is at the manager level and the rest are entry-level titles.

Only a handful of titles exist for persons working essentially as staff interpreters that are not explicitly interpreter titles. One such managerial title is at the state level (New Jersey) and another in a Superior Court of California (Santa Ana County). In addition, there is one such title in a county court (7<sup>th</sup> Illinois Judicial Circuit Court) and two in city/municipal courts (Laredo, Texas, and Plainfield, New Jersey).
