A tax rate of \$0.049895 per \$100 valuation has been proposed by the governing body of EMERGENCY SERVICES DISTRICT 4.

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for EMERGENCY SERVICES DISTRICT 4 from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval tax rate is the highest tax rate that EMERGENCY SERVICES DISTRICT 4 may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that EMERGENCY SERVICES DISTRICT 4 is proposing to increase property taxes for the 2023 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD on Wednesday September 6, 2022, at 7:00 P.M. at 28036 Old Boerne Stage Road, Boerne, Texas, 78006.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, EMERGENCY SERVICES DISTRICT 4 is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the EMERGENCY SERVICES DISTRICT 4 at their offices or by attending the public meeting mentioned above.

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.
