Dansville ArtWorks is seeking 2D and 3D artists to participate in the spring exhibit at 153 Main Street. The theme of the exhibit is “Spring Awakening” and submissions should reflect: nature, wildlife, agriculture, springtime, renewal, or make a clear connection to the theme. The exhibit will coincide with Dansville’s Dogwood Festival.

Guidelines for Submitting Items

- ☐ Submit up to 3 items related to the theme. Work must be delivered in person on delivery day to 153 Main Street with a Dansville ArtWorks volunteer and picked up on pick-up day. If you have a hardship, please contact dansvilleartworks@gmail.com.
- ☐ Item must be ready to hang (2-D items should have wire hanging on back) or ready to display (stands, etc.). Some structures are available for small sculptures. 2D items should aim to use plexiglass instead of glass if possible. Artwork not ready to hang will be refused until ready or optionally, artist may pay \$5 per piece at delivery for Dansville ArtWorks to prepare artwork for hanging.
- ☐ All items must be original and the work of the artist, no kits or reproductions.
- ☐ Artists must be 18 years of age or older.
- ☐ All items must be family friendly. If you are not sure, then it probably is not.

- All items must be available for sale. Dansville ArtWorks will retain 25% commission on all sales. Dansville ArtWorks will accept payment on your behalf; checks will be issued to the artist within 10 business days of the close of the exhibit.
- All items must be tagged with the name of the artist, price, title of work, and statement regarding connection of artwork to the theme (1-2 sentences that will be used in the program).

Entry Fee

- A non-refundable entry fee of \$25 (for up to 3 items) is due along with Exhibit Submission Form. Make checks or money orders payable to: Dansville ArtWorks. Debit/credit cards also are accepted in person or over the phone. The submission process is not complete until payment is received.
- Checks returned for insufficient funds or closed accounts will be subject to \$30 service charge in addition to amount of check.

How to Submit

- Submission materials including paperwork and fee should be delivered with your artwork during business hours, March 29 – March 31.
- **Do not bring any artwork until the drop off dates.** Artwork not delivered on the drop off date without other arrangements made in advance may not be accepted for the exhibit.
- Please email up to two (2) photos in .jpg format for use in promotional materials and social media; each image labeled with title and your name to: DansvilleArtWorks@gmail.com. Be sure to sign the photo release section of the submission form.

Artist Agreement

I understand that I will be required to drop off and pick-up unsold items at designated times. After formally received by a Dansville ArtWorks representative, between the drop off and pick-up period, my work is insured against damage and theft for 50% of the value (value is retail price – 25% commission). Otherwise, I release Dansville ArtWorks, its Board of Directors, employees, volunteers, and the building landlords from any and all liability. Dansville ArtWorks is not responsible for items delivered early or picked up late or dropped off without Dansville ArtWorks receipt. Dansville ArtWorks will hold items for 15 days after the pick-up date; items not picked up may be disposed of if arrangements have not been made. Sales of any submitted pieces paid to Dansville ArtWorks will be paid to the Artist within 10 business days of the close of the term less 25% commission to Dansville ArtWorks. Furthermore, I agree to do my best to promote my participation in the Dansville ArtWorks exhibit to my networks which may include social media, websites, press releases, or groups in which I participate.
