# Lay Workers TINY CHILDREN WITNESS FOR JESUS

Note: The experience below is a continuation of Genaro Oliva's story in the previous issue of the MPI Update. The original format has been retained, as it appeared in the MPI Newsletter in 1992.



Adventist layman Genaro Oliva lives in a small dwelling with his wife and eight children in the mountains of Chiapas, Mexico. Genaro has dedicated his life to full-time evangelism, and his older sons often accompany him in his work. One morning as the family sat down for their breakfast of beans and tortillas, they noticed that four-year-old Genaro Jr. and six-year-old Janet were missing.

A few minutes later the children appeared, and much to the surprise of their parents, they had been visiting the home of an unbelieving family down the street. For many months this family had rejected the Gospel, yet these two children decided to follow the example of their daddy and share their faith with them. The family felt touched by the testimony of these tiny

children, and accepted Bible studies from Genaro.

After this experience, Genaro Jr. and Janet continue telling others about Jesus. They like to visit homes early in the morning before the families leave to work in the fields. Upon entering a home, Genaro Jr. prays silently while six-year-old Janet tells the family how much Jesus loves them. "He wants you to repent of your sins and give your hearts to Him" she continues. "Then vou can live in heaven with Jesus when He comes." The testimony is short, but it leaves a strong impression upon the listeners! Even though she cannot read, Janet holds an opened Bible as she speaks. Genaro Jr. finishes with a prayer, and the children ask if the family would like their daddy to study the Bible with them.

At least one family that was initially visited by these children is now receiving Bible studies from their dad Genaro, and the parents plan to be baptized in the near future.

If God can use these small children to lead families to salvation, He can certainly use any of the rest of us who are willing to do what we can!

Note: Genaro and his family eventually moved to another area, and are no longer sponsored through MPI. I've been out of touch with them for many years, but look forward to the day when we can meet in Heaven and see the results of the seeds that have been planted

through the united efforts of MPI donors and workers on the front lines - such as these precious little children.

# **Worthy Student Aid**

Dear MPI Friends,

It is a pleasure for me to greet you and congratulate you on such a good and noble work in benefit of some of us that yearn to come out ahead but whose economic situation does not permit us to do so.

I grew up in a small town in south Mexico and completed high school. Finishing there, I opted to go to college, but without economic resources, since my mother could only give my siblings and me food and a roof over our heads. I went to the city of Tuxtla Gutiérrez, Chiapas, where I found a college and a job as a cashier in a self-service shop. This helped me sustain my studies and help my family at home. But only a few months passed when I had an electrical accident, and as a result, they amputated a third of my left arm and part of my right leg.

Because of what happened, I lost my job and could not continue at that college. My family didn't know how to help me recover, and caused more injuries to me. I became very depressed and tried to kill myself. An Adventist family heard of my condition and begged me to come to Linda Vista, where I chose Education as my major, specializing in Physics and Mathematics.

Even though I am still not an Adventist, coming to this institution has been a great blessing. Now I am in the fourth semester of my studies, but because of my condition I cannot work normally and my mom has no money. For this semester, I was going to go home for a lack of resources, but thanks to God and your help, I believe that I will be able to finish my studies.

I want to finish my degree to show myself that everything is not over for me. I want to support my mom economically and I want to walk with Jesus. May God bless you all and thank you for your support.

Every year MPI receives new requests for additional Lay Workers and for Bibles and literature, to build and to roof churches and schools. There are always more requests than we are able to fill. Yet somehow in our small humble way the work advances. Men, women and youth are won to Jesus. New groups of believers spring up here and there. Annual baptisms run between 450 and 600. We praise God for each miracle. Each one is precious in his sight!

This year La Loma Luz Adventist Hospital teamed up with Mission Projects, Inc. to hold a couple of campaigns. The Hospital Chaplain, Collet Montejo, held a series in Belize City. Ruth and I held another in the Spanish Village of Buena Vista. We reported our experience in a previous newsletter. I visited the Buena Vista Church the first Sabbath after my return to Belize in January. I was pleasantly surprised when seven more individuals were baptized that day, bringing the total baptisms to twenty-four.

As I write, students from DayStar Academy are returning from Belize. The students conducted a follow-up campaign at Buena Vista. They worked with one of our Belizean Lay Workers, Joel Recinos. Joel and his wife were baptized in 2003.

The Buena Vista Church is full to overflowing. MPI sponsored this Church about ten years ago. The footings for an addition have been laid. If you feel impressed to help with this project, please mark your gift: *Buena Vista Church, Belize*. Thank you.

# Persecuted Huichol Will Become Fishers of Men and Fish!

We are grateful to God that He is opening the way for the forty-six Huichol persecuted Adventists who have been living at the SDA campgrounds south of Guadalajara since being cast out of their homelands in the Sierra Madres Mountains of Mexico last August.

The friendly pueblo of Aguas Milpas, which is near the mountains where they once lived, has donated over 200 acres to these brethren where they will be able to live in religious freedom. The land, accessible only by boat, is situated 25 miles up the lake on a barren hillside above a large a hydro electric reservoir.

The residents of Aguas Milpas who are donating the land to our brethren are fishermen (we are told this lake has the best bass fishing in all of Mexico).

American sports fishermen come here and so we believe the Adventist families too will become fisherman as well as grow corn. The challenge now is to help them to build simple homes and a church.

But the first priority is finding two boats for them, one for transport and one for fishing: A small one, like 10' to 12" like a flat bottom Jon boat for fishing, and a 21' with a good motor for transporting goods and people.

God is so good. We thank MPI donors who raised \$3,500 for these dispossessed and faithful Huichol. There is more to do, but we know God will provide.

Upon arriving in the village, Chiinda decided that he would try and visit this man. He began a friendship with him. When the evangelistic series started, this man was the very first student in come to an afternoon Bible study. As the studies progressed, the man joined the baptismal class. Soon he stopped smoking, and felt convicted that he should not continue living with two wives.

He ultimately decide to divorce his second wife. At the end of the meetings, this man who had been so opposed to Christianity for many years made a full surrender. He gave himself to Christ in baptism. A special joy for Chiinda was to see that the divorced wife also accepted Christ and was one of 76 people who were baptized.

# La Loma Luz Adventist Hospital Administrator's Corner

Since this is my first communication with you, let me start by saying that my wife Ardis and I are really excited about the opportunity to join the team here at LLL. We want to thank the board members of MPI for allowing us to have this experience. It had been a dream of ours to serve as missionaries for the Lord's work for nearly thirty-five years.

On Tuesday, February 14, 2006, we arrived in Belize after driving five thousand miles from the Walla Walla Valley, located in Washington. We were able to visit with family members along the way, and after waiting three days for our papers to be approved, crossed over into Mexico and then on to Belize. As we drove the last eighty miles we knew that our driving adventure was coming to an end. The next two weeks were spent clearing customs, unloading our sixteen foot cargo trailer and starting all of the dozens of steps to obtain proper immigration documents.

Ardis and I have moved on several occasions, but until you make an international move you have not really moved. We look back at it with smiles on faces and happy thoughts in our minds as we saw how the Lord was leading, even when we made wrong turns, and dumb immigration mistakes. So many times we in North America judge the rest of the world by our way of doing things.

I would just share a thought that both in Mexico and Belize the local people have been wonderful and gracious. We did face a number of governmental issues in Mexico, but they are behind us and we look forward to traveling in Mexico again.

Early in March, 2006, DayStar Academy arrived to start a four week long stay. It was a great introduction for us to the many varied mission groups that come to Belize and to LLL to assist with the work in this area. They worked on the expansion of the Seventh-day Adventist church in Buena Vista and held a campaign there. They also were wonderful help with projects at LLL. At the end of the four weeks we had to say goodbye and it was done with a lump in throats because they had become part of our family.

On March 3, 2006, I flew back to the states for the MPI board meeting in of all places, DayStar Academy, Moab, Utah. I had never been to that part of Utah and I was doubly blessed in meeting the MPI board members and to enjoy God's second book, Arches National Park and the surrounding area. I must say though that it was a bit of shock to go from temperatures in the eighties in Belize to being in a major snow storm in eastern Utah. The white snow on the spectacular red rock was just beautiful.

Upon returning to Belize, I only had two days to get back into the saddle, and then a dental team from Loma Linda, California arrived led by Dr. Parks from northern California where he practices. They attended to nearly three hundred young people in just four days. They worked primarily in the village of "Valley of Peace." It is such a beautiful location and its name fits the location so well, but the community is there because of civil strife in other locations and many of these people are actually refugees from about fifteen years

ago, when the United Nations and the government of Belize worked together to provide new homes for about four thousand refugees.

On the last day that the dental team was with us we picked up seventy-one students and sponsors from Spencer-ville Academy from Maryland. They participated in many activities including a campaign in Bullet Tree, starting construction on a second Seventh-day Adventist church in Bullet Tree, painting the wing at LLL, and their choir singing for local churches and governmental officers. That large of a group presented many challenges, but the young people were cooperative and the sponsors were well organized.

Included within the group was Jim Lanning, ADRA Director for Acquisitions. In preparation for this trip, ADRA had sent two containers of medical and relief supplies for the benefit of the people of Belize. It was a wonderful experience to be a part of the distribution process that happened over the next several days. Nearly two weeks after the team returned to the states we were still able to provide vital medical supplies for both governmental and private clinics.

At the present time we have five young people from the states, in various stages of their medical training, volunteering, and we are using these supplies to supplement their work as they hold clinics in outlaying villages in western Belize. We must never forget that our medical work allows us to enter into a relationship with individuals that might not ever happen in any other way. Please remain connected to MPI and to LLL as we look forward to a strong working relationship with ADRA in the future.

There will be much to report in the future, but for now let me share with you that prayer and God's leading is our daily need as we develop this relationship. These past two months have shown Ardis and me how we constantly have to ask for the Lord to lead each day. We ask for your prayers daily, without them we will only be partially successful.
