USACE Workshop on Clean Water Act

The USACE will discuss how the 2015 Clean Water Rules changes jurisdictional determinations in California at their quarterly workshop on October 26, 2018 from 1:30-4:00 pm in Room 814 at Sacramento District Office.

Oroville Dam Construction Update

For the second year in a row, a report by the CA Division of Safety of Dams lists only one of the state's 1,200 dams as "unsatisfactory" - the Oroville Dam. DWR provided an update on spillway construction activities claiming the upper chute is 76% complete and will meet its November 1 date for completing concrete.

Shasta River Hydrologic Model Technical Comments Requested

The State Water Resources Control Board is seeking technical comments regarding development of a Shasta River hydrologic model. The deadline to comment is October 23, 2018.

Making State's Infrastructure Climate-Safe

A work group comprised of scientific and engineering experts released a report regarding making California's infrastructure more resilient to growing threats of climate change. It provides a framework for incorporating climate change impacts into planning, design, construction, operation and maintenance of critical infrastructure.

Federal Agency Overwhelmed by Disasters

A report by the Government Accountability Office (GAO) claims the Federal Emergency Management Agency (FEMA) was forced to rely on uncertified workers in key roles when multiple hurricane disasters and subsequent wildfires in California stretched their staff beyond their limit. In a letter responding to the GAO report critical of federal emergency response capabilities, the Department of Homeland Security acknowledged the nation's ability to respond and recover from multiple concurrent disasters was tested in 2017. Unfortunately the report did not provide any recommendations for improving disaster response in the

KEEPING UP

Hurricane Harvey Flooding in Texas Prompts Risk Management Recommendations

In response to extensive flooding and damage from Hurricane Harvey in 2017, the Texas Section of the American Society of Civil Engineers (ASCE) released a report with recommendations on improving inland flood risk management. California has already implemented some of their ideas including development of the Central Valley Flood Protection Plan, an annual levee inspection program for SPFC system, and annual notification of flood risk to landowners.

Increased Waste Discharge Fees Proposed

The State Water Resources Control Board issued a Notice of Proposed Emergency Rulemaking to raise Waste Discharge Fees by 9.5% for FY 2018-19. The water board is required to adjust the fees annually based on appropriations provided in the State Budget. This year's appropriation for the WDR program is \$33.4 million, but current fee revenues would only generate \$28.2 million. The proposed increase will generate another \$2.7 million and defer the balance to the next fiscal year.

Reclamation District Employment Opportunities

Due to Paul Devereux announcing his retirement, RD 1000 is seeking gualified candidates to serve as General Manager. Located in the Natomas Basin area of Sacramento, RD 1000 is the largest in California based on its 55,000 acre jurisdiction with agriculture and over 100,000 residents. Experience with budgets and an engineering, business, or public administration degree are required. Deadline to apply for RD General Manager position is October 12, 2018.

RD 1500 is seeking a qualified candidate to fill an Operations Manager position. Reporting to the General Manager, the Operations Manager oversees personnel responsible for the joint operations and maintenance of large public flood control and drainage infrastructure and private mutual water (irrigation) facilities in rural Sutter County. Oroville Dam Receives State and Federal Legislative Attention

Governor Brown signed into law Senator Nielsen's SB 955, creating a 19-member citizen's advisory commission to provide a formal venue for local residents and state representatives to discuss ongoing construction, maintenance and reports on the Oroville Dam. President Trump signed federal appropriations bill that includes language requiring FERC to conduct an independent review of Oroville Dam.

Congressman Doug LaMalfa (R-Redding) expressed concern when DWR disclosed in early September that the cost estimate for repair of the Oroville Dam spillways has increased to over \$1 billion, and may rise further before construction is completed in 2019.

Next Delta Leaders Wanted

The Delta Protection Commission is accepting nominations for participants in the 2019 Delta Leadership Program. Deadline to submit application is October 25, 2018.

Corps Releases Delta Levee Feasibility Study

The U.S. Army Corps of Engineers released the final EIS for the Delta Islands and Levee Feasibility Study. The draft report outlines a plan for reusing dredge material from the Stockton Deep Water Ship Channel to restore 340 acres of intertidal marsh at Big Break. The deadline to submit comments is October 21, 2018.
