WHEREAS, Section 31 provides that the Declaration, so long as it controls the Board, may amend this Declaration without the consent of the owners in order to attach an architect's statement that the buildings located on the property have been constructed in conformance with the architectural plans.

Said staking plan also includes "tie lines" showing the physical location of Buildings 11, 12, 13, 6, 7, 8, 9 and 10.

Except as herein amended, the Declaration remains in full force and effect.
