

# Ways and Means



Policy Committee hearings are the forums for public input, the best place for citizens to communicate their concerns about proposed legislation. Bills are heard in **Standing Committees** which meet on a regular basis throughout the year. **Joint Committees** have membership from both houses and consider issues of joint concern. <u>Call or write Members of the committee in which the bill is being heard!</u> Committee information available online includes committee membership, staff, addresses, phone numbers, meeting schedules, and policy jurisdictions.

#### SB 598 (HUESO) PUBLIC UTILITIES: GAS AND ELECTRIC SERVICE DISCONNECTIONS

<u>STATUS</u>: Placed in the Senate Appropriations Committee "Suspense File": A bill or set of bills, with a fiscal impact, set aside in Appropriations Committee by a majority of Members present and voting. These bills may be heard at a later hearing. (04/17/17)

<u>SUMMARY</u>: Requires the California Public Utilities Commission (CPUC) to adopt rules, policies, and goals to reduce disconnections of utility service for nonpayment and prohibits disconnections of residents on life support. According to the CPUC, implementation of this bill will require two Public Utilities Regulatory Analyst III positions to staff a disconnection rulemaking, produce reports to the Legislature, and act as ombudsman(s) on all rate or revenue requirement increase proceedings to assess impact on disconnections. An Administrative Law Judge will also be required to administer a disconnection rulemaking and any associated applications or settlements to establish policies, rules, or regulations to reduce disconnections by 2021; determine how to incorporate the metric of residential disconnections for non-payment into certain proceedings; and, potentially adjudicate disputes between customers and the utility for new prohibition on disconnection for non-payment.

<u>FISCAL IMPACT</u>: Approximately \$391,000 annually (Public Utilities Commission Reimbursement Account) to the CPUC for staff necessary to develop policies, rules, or regulations to reduce gas and electric disconnections by 50% by 2021; to assess the impact on disconnections for every potential rate or revenue requirement increase, as well as use disconnections as a metric for certain proceedings; and to create the required report.

#### AB 801 (WEBER/GLORIA) COUNTY OF SAN DIEGO CITIZENS REDISTRICTING COMMISSION

STATUS: Currently in the Assembly Local Government Committee. (04/05/17)

<u>SUMMARY</u>: Repeals existing provisions of law requiring a redistricting commission made up of former or retired judges to adjust the boundary lines of supervisorial districts in San Diego County after each decennial federal census, and <u>instead</u> establishes a Citizens Redistricting Commission in the county and charges it with adjusting the boundaries of supervisorial districts. Changes the criteria to be used when the boundaries of supervisorial districts in San Diego County are adjusted. There are 34 provisions with sub-sections in this bill, which would create a <u>new commission of 14 members</u> no later than December 31, 2020, and in each year ending in the number zero thereafter to redistrict the supervisorial boundaries in San Diego County.

Requires the political party preferences of commission members, as shown on the members' most recent voter registration affidavits, to be as proportional as possible to the total number of voters who are registered with each political party in San Diego County or who decline to disclose or do not indicate a party preference, as determined by registration at the most recent statewide election. Provides that the political party preferences of commission members are not required to be exactly the same as the proportion of political party preferences among the registered voters of the county. Requires at least one commission member to reside in each of the existing five supervisorial districts in San Diego County.

FISCAL IMPACT: Unknown. State-mandated local program; contains reimbursement direction.

# AB 805 (GONZALEZ-FLETCHER) TRANSPORTATION AGENCIES IN SAN DIEGO COUNTY; TRANSACTIONS AND USE TAX

STATUS: Currently in the Assembly Committee on Transportation (04/20/17)

SUMMARY: Basically, this bill consolidates the workings of the board of directors of SANDAG, the San Diego Metropolitan Transit System, and the North County Transit Board. This bill would require the mayor of each city to serve on the board of directors, except in the case of the City of San Diego, where the mayor and the president of the city council would serve. The bill would require the chairperson of the County of San Diego board of supervisors to serve on the board as one of the two members on the board from the county board of supervisors. The bill would also revise the selection of alternate members of the board. This bill would additionally authorize MTS and NCTD to individually impose a transactions and use tax within their respective portions of the County of San Diego, with revenues to be used for public transit purposes, as specified, serving their jurisdictions, and to issue bonds backed by these tax revenues, subject to similar requirements.

FISCAL IMPACT: Unknown.
