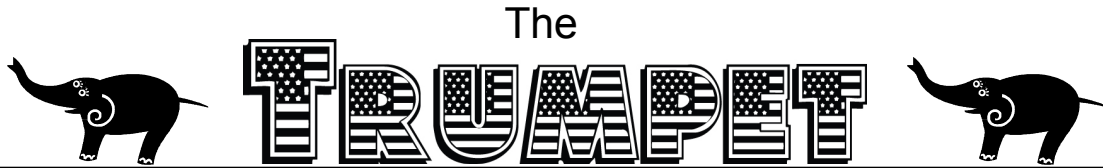

DON JANS, NATIONALLY ACCLAIMED AUTHOR AND SPEAKER

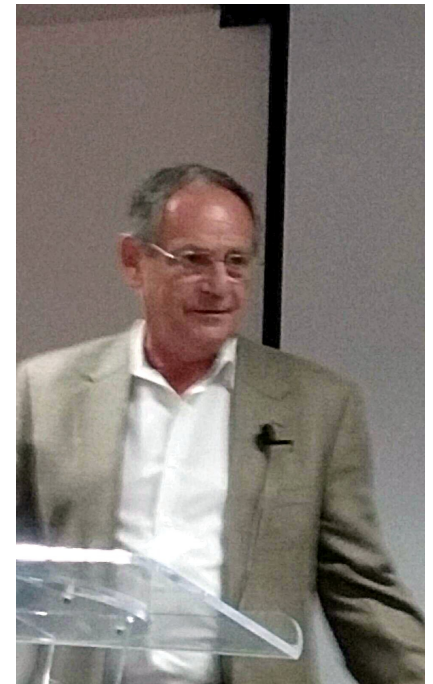

LEGISLATION

AB 1223 Firearms and Ammunition: excise tax
This law was amended by adding Sec.6. stating this act is an urgency statute necessary for the immediate preservation of the public peace, health, or safety within the meaning of Article IV of the California Constitution and shall go into immediate effect. The facts constituting the necessity are:
California is facing a public health crisis due to gun violence. According to the Gun Violence Archive, in the first five months of 2021. There have been 240 mass shootings in America. From January 1, 2021, to June 1, 2021, a total of 18,132 Americans were killed due to gun violence. It is necessary for this act to take effect immediately in order to address this ongoing public health crisis at the earliest possible time.

Fact Check: According to the New York Times: in CA during that same time frame there were a total of 4,243,746 cases of Covid 19 reported in CA and 64,727 deaths occurred due to the virus. But gun violence is their highest priority.

A little history lesson and a heads up about things to come: In 2016 Governor Jerry Brown approved SB1383 and set January 2024 as the deadline for the methane emissions regulations to go into effect. But CARB and the CDFA in partnership with stakeholders and other groups must determine if the strategies used are reasonable for the animals and the dairy industry. They must determine if SB 1383 are technologically feasible and cost effective for the industries that will be impacted by them. Yes, livestock and manure regulations actually exist. In California 90 percent of methane emissions come from the dairy industry. By law, all money collected by the state goes through the cap-and-trade programs into funding for other climate change programs such as clean transportation, energy, forest fire prevention, and technology upgrades at facilities. In 2019 CARB reported \$1.4 billion in funding which is double the amount from 2017. The restrictions on these programs to reduce carbon dioxide emissions become stricter over time. For example, one regulation requires zero-emission delivery trucks and cargo handling equipment by 2045. The restrictions imposed by this legislation is not contained in one little nice and neat package, it is contained in multiple bills that have been passed over many years. Such as AB 617 the Community Air Protection Program, AB 32 established the states 2020 GHG Reduction Target, it also mandated policies to reduce GHGs to avoid businesses and jobs from leaving the state, etc. This is a very complex piece/pieces of legislation that will be playing out in our lives in the next few years and we all will be impacted by this in various ways. I encourage all of you to get informed about what our future will unfold.

URGENT!

MAIL IN YOUR BALLOT TODAY

HOW TO VOTE SECURELY IN THE RECALL ELECTION

The most secure way to vote in the Recall Election is BY MAIL, then use the safe and secure BallotTrax (See Below) to track your ballot all the way through the process.

If you still want to vote in person, you can do so now at your county's vote centers.

1. Every voter should have received a ballot in the mail.
2. The first question on your ballot is "Should Gavin Newsom be Recalled?"
VOTE: YES to Recall Gavin Newsom
3. On the second question, vote for your favorite candidate.
4. Seal and drop your ballot in the mail. No postage stamp is needed.

HOW TO TRACK YOUR BALLOT AFTER IT'S MAILED

Tracking when your ballot is received, and counted, has never been easier.



1. Scan the QR Code or visit BallotTrax at <https://california.ballottrax.net/voter/>
2. Enter your basic information to track your ballot.



Remember, options for voting on Election Day may be more limited than in past elections. Don't take a chance! Mail your Recall ballot today!

NOTE: IF YOU LIVE IN A FIRE ZONE AND DID NOT RECEIVE A BALLOT, CONTACT YOUR COUNTY REGISTRAR OF VOTERS TO OBTAIN A REPLACEMENT BALLOT OR FOR INSTRUCTIONS ON HOW TO VOTE.

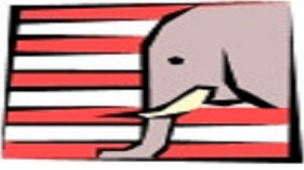
