Will start 95,000 house feeds in October; Big Prairie, Everett, Goodwell then north. Will get ½ the county, rest is Consumers Energy. Talked with Bill White to encourage giving towships internet for lower, vacationer rate. Will have a Health Department meeting, may change county activities due to mandates. Everett likely to have M-20 corridor be mixed use. Keep businesses on big roads. Paul asked about Autumn Olive brush and the problems it causes. What can be done about it. No real answer.
 - Steven: Beech is not serviced, does that mean it is no longer a road? Can it be blocked, to keep non residents out? If county does not fix the road, the township does not maintain. Township goes through county. A road often must be kept open, even if not maintained to deal with fire. Check with county road commission.
