Regional Grand National & Games Entry Requirements:

Dogs must have an Open title earned prior to entering to be eligible for entry into the Barn Hunt Regional. No provisional entries will be accepted at any time. Entries will be accepted on a first received basis.

*Dogs who are entering ALL FOUR SENIOR, MASTER OR CHAMPIONSHIP RUNS: *You are automatically entered in the Regional Grand National Competition

If entering Team, both dogs BH number must be listed or the entry is not valid.

You must indicate by circling Y or N to each statement about FEO (For Exhibition Only). Refer to the Regional Rules if you have questions about FEO.

Team dogs may have different level titles (e.g., one dog has a Master or Championship title and the other a Senior title).

Notice to Exhibitors:

Crating

Crating will be in building "A" (first building- letter is marked above the door). The crating area is climate controlled with foam matted floor (obedience rings), Restrooms, kitchen area and video feed of trial rings available. NO EX PENS ALLOWED. Waterproof plastic or tarps must be under all crates in the crating area.

Collars and Leads

Electronic collars, head halters, bark collars and muzzles are not permitted on Barn Hunt show grounds. Collars and/or harnesses which can be removed and replaced quickly and easily are strongly recommended for the ring. All dogs must always be on lead or crated unless actively working.

Dog Agression

Any dog behaving in a threatening or aggressive manner towards another person or dog may be dismissed from the trial if justification is found by the trial committee or any judge.

Refunds/Cancellations

No refunds will be made for cancellations after the closing date or entries which are absent, disqualified, excused or barred from competition by decision of the Trial Committee. Exception - Injured dogs with a note from their Veterinarian.

Food

There will be food available on site for purchase (additional details will be provided in the final confirmation email). There are also various fast food restaurants within 1 mile of the facility at Alum Creek Rd. and 270.

General Info

Exhibitors are responsible for being in the staging area when it is their turn to run. The entire grounds of CATC are considered Barn Hunt trial grounds, all rules set forth by BHA are to be followed.

Bitches in Season (BIS)

BIS may compete in Barn Hunt and will be run at the end of each class. All BIS must wear pants at all times except when being pottied. There will be a separate crating area and potty area for all BIS. Please advise the secretary of a BIS, as soon as possible, prior to the trial.

COVID-19

COVID-19 Compliance is required at this event. Rules as of July 1, 2021, subject to change. BHA COVID Rules: <https://www.barnhunt.com/rules/covidrules.pdf>. Additionally, CATC currently has a mask mandate in effect due to the current mandate by the City of Columbus, which requires everyone to wear a mask when inside the buildings. This mandate is subject to change based on the current conditions of COVID-19 and additional details will be provided in the final confirmations sent out prior to the event.
