TABLEDINFORMATIONAL UPDATE ON WATER TANK PROJECT – D. OHMAN/
BUSINESS:DELAWARE ENGINEERING:

David Ohman of Delaware Engineering updated the Public on the Water Tank Project:

Reason for Project

- The 500,000 gallon in ground tank constructed in 1914 is in need of repair; concrete walls are failing tipping into tank.
- No way to take the tank off line to repair since the tank is needed to maintain pressure and volume to the system.
- Tank leaking (exfiltration) now and could fail anytime.

Planned Work

• Construct a new \$500,000 gallon above ground concrete tank on Village-owned property adjacent to the existing tank.

<u>Status</u>

- Preliminary engineering complete; siting done
- Preliminary funding determination from USDA RD received June 4, 2012
- Final funding application due to USDA RD on August 17, 2012
- Next steps = Detailed design followed by NYSDOH and USDA review, then bidding and construction

Project Cost

- Estimated project cost = \$1,031,000
- Project Funding
 - Per June 4, 2012, USDA RD preliminary eligibility determination, project funding will be as follows:
 - Grants \$731,000
 - Loan: \$289,000 (2% for 38 years)
 - Local: <u>\$ 11,000</u> (Cost to do application and SEQR review)

\$1,031,000

- Annual debt service cost for \$289,000 at 2% over 38 years = \$11,000/year
- Spread out over 1,537 service connections results in an estimated \$7/year in addition to the \$286/year already being paid by each service connection

Dave Ohman continued by stating:

- Other items for tonight:
 - Bond Resolution adopt tonight see attached (format taken from 2011 USDA water project)
 - Allows the Village to secure permanent (serial bonds) and short-tem (bond anticipation note) financing for the full project (suggest using up to \$1.2 million as project estimate is \$1.1 million)
 - With USDA funding, village needs to borrow money up front and then get reimbursed as the project proceeds so both up front (Full amount) and long-term (lower amount = loan and local share portion as grant is applied) financing is needed.
 - Publication of notice in Village's official newspaper of that Board adopted bond resolution subject to permissive referendum resolution.
 - Need Board to authorize Clerk to publish
 - Clerk publishes this week and obtain Affidavit of Publication from paper and sent to Delaware
 - Publication of notice in Village's official newspaper minimum of thirty (30) days after the Bond Resolution assuming no petitions were filed.
 - $\circ~$ Publish in official newspaper August 9th or shortly thereafter and obtain Affidavit of Publication from paper and sent to Delaware before August $15^{\rm th}$

BOND RESOLUTION DATED JULY 9, 2012

A RESOLUTION AUTHORIZING THE CONSTRUCTION OF, AND APPURTENANT WORK AND SERVICES RELATED THERETO FOR, THE REVONAH HILL WATER STORAGE TANK IMPROVEMENTS, AS PART OF THE WATER DISTRIBUTION SYSTEM OF THE VILLAGE OF LIBERTY, AUTHORIZING THE ISSUANCE OF SERIAL BONDS OF THE VILLAGE OF LIBERTY, SULLIVAN COUNTY, NEW YORK, IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$1,200,000.00 PURSUANT TO THE LOCAL FINANCE LAW TO FINANCE SAID CONSTRUCTION AND RELATED WORK, AND DELEGATING THE POWER TO ISSUE BOND ANTICIPATION NOTES IN ANTICIPATION OF THE SALE OF SUCH BONDS TO THE VILLAGE CLERK/TREASURER

BE IT RESOLVED, by the Board of Trustees of the Village of Liberty, Sullivan County, New York (the "Village") (by the favorable vote of not less than two-thirds of all the members of the Board) as follows:

SECTION 1. The specific purpose (hereinafter referred to as "purpose") to be financed pursuant to this resolution is to perform improvements to the Village's water distribution system, including construction of a new water storage tank and appurtenances, and necessary services related there to, for the foregoing purpose (the "Project"). The estimated maximum cost of said purpose, including preliminary costs and costs incidental thereto and the financing thereof, will not exceed \$1,200,000.00 and said amount is hereby appropriated therefor.

SECTION 2. The Board of Trustees plans to finance the Village's maximum estimated cost of said purpose by the issuance of serial bonds in an amount not to exceed \$1,200,000.00 of said Village, hereby authorized to be issued therefor pursuant to the Local Finance Law.

SECTION 3. It is hereby determined that said purpose is an object or purpose described in subdivision 1 of paragraph (a) of Section 11.00 of the Local Finance Law and that the period of probable usefulness of said purpose is forty (40) years.

SECTION 4. Current funds are not required to be provided prior to the issuance of the bonds authorized by this resolution or any notes issued in anticipation of the sale of said bonds.

SECTION 5. It is hereby determined that the proposed maturity of the obligations authorized by this resolution will be in excess of five (5) years.

SECTION 6. The faith and credit of said Village are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. There shall annually be levied on all the taxable real property of said Village a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.

SECTION 7. Subject to the provisions of this resolution and of the Local Finance Law, pursuant to the provisions of Section 30.00 relative to the authorization of the issuance of bond anticipation notes or the renewals of said notes and of Section 21.00, Section 50.00, Sections 56.00 to 60.00, Section 62.00 and Section 63.00 of the Local Finance Law, the powers and duties of the Board of Trustees pertaining or incidental to the sale and issuance of the obligations herein authorized, including but not limited to authorizing bond anticipation notes and prescribing the terms, form and contents and as to the sale and issuance of the bonds herein authorized and of any bond anticipation notes issued in anticipation of said bonds, and the renewals of said notes, are hereby delegated to the Village Clerk/Treasurer, the chief fiscal officer of the Village.

SECTION 8. The Village Clerk/Treasurer is further authorized to take such actions and execute such documents as may be necessary to ensure the continued status of the interest on the bonds authorized by this resolution, and any notes issued in anticipation thereof, as excludable from gross income for federal income tax purposes pursuant to Section 103 of the Internal Revenue Code of 1986, as amended (the "Code") and to designate the bonds authorized by this resolution, and any notes issued in anticipation thereof, as "qualified tax-exempt bonds" in accordance with Section 265(b)(3)(B)(i) of the Code.

SECTION 9. The Village has determined that the Project will not have a significant effect on the environment and, therefore, no other determination or procedures under the State Environmental Quality Review Act ("SEQR") are required.

SECTION 10. The expected source of funds to be used to initially pay for the expenditures authorized by Section 1 of this resolution shall be from the Village's General Fund. The Village then reasonably expects to reimburse such expenditures with the proceeds of the bonds or bond anticipation notes authorized by Section 2 of this resolution. This resolution shall constitute a declaration of "official intent" to reimburse such expenditures, as required by the United States Treasury Regulations, Section 1.150-2.

SECTION 11. The validity of said serial bonds or of any bond anticipation notes issued in anticipation of the sale of said serial bonds may be contested only if:

(1) (a) Such obligations are authorized for an object or purpose for which said Village is not authorized to expend money, or

(b) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication; or

(2) Said obligations are authorized in violation of the provisions of the Constitution of New York.

SECTION 12. The Village Clerk/Treasurer is hereby authorized and directed to publish this resolution, or a summary thereof, together with a notice in substantially the form provided by Section 81.00 of said Local Finance Law, in the Sullivan County Democrat, a newspaper having a general circulation in said Village and hereby designated as the official newspaper of said Village for such publication.

SECTION 13. This resolution is adopted subject to permissive referendum pursuant to Section 36.00 of the Local Finance Law.

WWTP IMPROVMENTS PROJECT

David Ohman reported on the following:

Oxidation Ditch - Emergency Repair Work -

- Two (2) ITT-Xylem submersible mixers
 - Both units now on site
 - Will need to be on-site to start up after TAM gets 1st unit installed week of June 18 or 25 (date pending)
- Ross Electric work underway
 - New Mixer panels and variable frequency drives are installed.
 - Ox Ditch 1 Mixer connected and operating
- TAM Enterprises work underway:
 - Mixer and davit crane installed in Oxidation Ditch 1, flow transferred over to this tank and operating since July 2.
 - Working this week to clean Oxidation Ditch 2 and install new mixer and do tank leak patching (between Ox Ditch 2 and Storm water tank)
- Cost remain within the planned \$145,000 budget
- Work is anticipated to be completed by July 20
- WWTP monitoring dissolved oxygen levels and are lower than desired with only one brush aerator working (<1.0 pp,) affects plant performance (e.g. ammonia removal) may need to do something more.

<u>Near Term WWTP Improvements</u> – Oxidation Ditch Aerator and Influent Screens

- Working with the Village Grant Writer, Mark Blauer, on the CDBG application for a \$600,000 grant needs to be submitted July 17.
- Environmental Review
 - Only physical disturbance to land includes excavation for building foundations for the small new screenings building going over top/around the current influent channel – this area has already been excavated/distributed – therefore, this is a Type 2 project

which required no formal review or determinations. However, since the grassy area adjacent to the work is classified as archaeologically sensitive, we prepared and forwarded to SHPO the two page SHPO Project Review form along with descriptive information from our reports to facilitate SHPO review.

CONSIDER MOVING FORWARD WITH FINANCING FOR THE EMERGENCY REPAIRS AT THE WWTP

Motion by Trustee Stoddard, seconded by Trustee McGuire and unanimously carried to move forward with the financing to begin the Emergency Work that needs to be done at the Waste Water Treatment Plant.

The amount to be financed will be \$904,000, plus \$145,000 for the Emergency Oxidation ditch and \$193,000 to pay back money to the other funds that have lent the sewer fund money for these issues. Therefore the total borrowed on a short term basis will be in the range of \$1,242,000.

IDEAL SNACKS – UPDATE FROM DELAWARE ENGINEERING

David Ohman of Delaware Engineering reported that the trapzilla is planned to be installed next week per the 07-06-12 e-mail from Ideal's Jesse Shultis:

Background:

Based on April 26 meeting, Ideal Snack will:

- Install a grease trap (Trapzilla) on the sewer line that discharges in the Village System upstream of the second discharge that already has a Village system upstream of the second discharge that already has a Trapzilla should reduce fats/oils/grease. Ideal plans to install it very soon.
- Pay for and coordinate clean out Elm Street pump station after second Trapzilla goes in (coordinate with Village DPW)
- With Village DPW (Peter Parks) monitor grease accumulation in Elm Street PS clean out semi-annually or more frequently if needed.
- Pay for and coordinate cleanout force main from Elm Street PS to gravity sewer if determined to be needed. Look at annually or more frequently of needed.
- Conduct some more wastewater sampling to establish levels of BOD, TSS, FOG going into the Village system and determine if more treatment is needed.
- Village will look at options and cost for installing new grease collection in WWTP secondary clarifier peripheral feed areas and what to do with collected grease.

RED MEAT FACILITY – UPDATE FROM DELAWARE ENGINEERING

David Ohman of Delaware Engineering said there is not anything new to report on this matter.

STATE POLICE BARRACKS NEVERSINK ROAD

David Ohman of Delaware Engineering reported:

- Still working to resolve the scope of improvements work with Sgt. Nishanski
- Agreed upon likely required scope with Pam Winters
- Sent copy of agreement to Sgt so he could see why engineering was required.
- We have reviewed the scope of work and procurement procedures with the Troopers and will be refining a project estimate soon and will be preparing a contact for engineering services for this work for the Village for which cost can then be passed thru to State Police

Background:

- Front entrance, front steps, H/C accessible sidewalk and portions of front sidewalk require repair and replacement.
 - Settlement Issues
 - Deterioration of some concrete
- Cost of repairs will be paid by NYS
- Village desires to have engineering plans done to provide details of repairs for quoting, construction and future record and for code compliance review.

DAYS INN PUMP STATION SANITARY FORCE MAIN – EXPOSED PIPE

David Ohman reported on the following:

Update

- NYSDEC's John Sansalone has agreed in concept to covering the existing pipe with low profile cover as a short-term measure (less than 10 years).
 - Wants us to confirm that Interstate 86 Improvements will not be affecting the existing culvert – if DOT changes are happening, do the permanent solution in concert with DOT changes.
 - Received reply from NYSDOT's Dean Smith that NYSDOT is not planning any major changes
 - We will now respond to NYSDEC's John Sansalone that NYSDOT will not be making any major changes and that Village plans to do short-term low profile cover fix.
- Working to review this with NYSDEC's Permits and Fisheries personnel in a preapplication meeting. Will get a date and contact WWTP personnel [try to have it in Liberty so that DEC can see the issue.
- Contractor who will do the Village work will have to get a DOT work permit.

Background:

• NYSDEC early 2012 inspection of the Village's sanitary collection system and wastewater treatment facility and noted that the Days Inn Pump

Station sanitary force main is exposed at the Mongaup Rover crossing. The force main also crosses under State Highway 17/Future I-87 and continues to WWTP.

- NYSDEC requested a report to be submitted on how the problem is to rectified by May 1, 2012. NYSDEC noted that design standard for pipes in such stream/river crossings call for pipes to be encased in concrete with adequate burial depth.
- Delaware drafted letter for Mayor to send to DEC stating that options were being investigated.
- Issues:
 - <u>NYSDOT</u>:
 - the force main is located in the bottom of NYSDOT's 5'-8' corrugated metal drainage pipe that crosses under Rte 17.
 - DOT is planning to line this culvert pipe
 - Need to determine if DOT has any desires/plan to move the force main before lining the culver and conform what and when they intend to do.
 - Working in Stream
 - Trout stream so all work needs to take place in accordance with Article 15 streamwork permit which typically requires work to be restricted to June 15 to September 1.
 - Working to set up a pre-application meeting with DEC, Sansalone – as technical person, as well as people from permits, fisheries and habitat.
 - Need to figure out what may be acceptable to DEC
 - Access/ROWs
 - Plan to come in from Days Inn but need to find out what ROWs exist and if they are adequate
 - If directional bore under 17 done, need figure out where to land
 - Scope and cost
 - Option 1 leave pipe as is and cover with low profile device construction cost \$15,000?
 - Option 2 leave pipe in DOT culvert, cut and lower it in the stream and encase in concrete \$50,000?
 - Option 3 take pipe out of DOT culvert, directional bore from Days Inn to other side of Route 17 and reconnect – less than \$100,000?

CONSIDER ELIMINATION OF DAM – GRIEBEL PARK SWIMMING POND/DAM

Mayor Winters said the Cooperative Extension is now involved with helping the Village and all the information to move forward has been given to them by Department Head Kenneth Hessinger.

CONSIDER POSSIBLE AMENDMENT TO LOCAL LAW RE: WATER METER SERVICE

Clerk-Treasurer Zurawski said she would try to work with Ken Hessinger to complete this amendment which will tighten up everything in the code.
