Yellow ribbons were attached to 26 trees by a Forever Green arborist to determine quantity and location of Ash trees in our community. Unfortunately, Northwest Indiana and other large areas in the Midwest have been infested by the Emerald Ash Borer which is killing the trees.

More info to follow this spring.

Currently the plan is to have four Community newsletters during the year: Winter (January), Spring (April), Summer (July) and Fall (October). It is planned to distribute most newsletters by email to save on mailing costs.

There is a rumor going around the community that if a resident desires to do services on their property that are provided by the Association, they can deduct the cost of the service from their monthly assessment. That is totally untrue and could ultimately result in legal action such as a lien being placed on his or her home for unpaid assessment and attorney fees.

Still need a few more votes to pass our three proposed amendments: (1) Association responsibility of trees and bushes, (2) Board member "good standing" requirements and (3) Architectural review committee jurisdiction. Please contact Peter Bylen or any Board member for further clarification.

Coyotes have been observed in our community, so please keep a watchful eye on your pets if they are outside.
