d. Ronfeldt made a motion and Bebee seconded to approve the agreement with Bruce Tevis to place sheep in the lagoon area for the 2021 summer season. No further discussion. All ayes...MC.

e. Ronfeldt made a motion and Matthias seconded that the City participate in the Highway 141 Garage Sales and remit the \$100 advertisement fee. No further discussion. All ayes...MC.

f. Bebee made a motion and Johnston seconded to approve Chancers R Liquor and Tobacco Licenses. No further discussion. All ayes...MC.

g. The City declines the opportunity to appoint a representative to the Northwest Iowa Regional Housing Authority board as no one is available.

h. Bebee made a motion and Matthias seconded to approve the proposal for purchase of desktop computer and 2 printers for \$2,400.00 with the Ram upgraded to 32GB. No further discussion. All ayes...MC.
